# AMENDMENTS TO THE CHARTER OF THE BRITISH SCHOOL AT ROME

- 1. Article 3(4) *delete* and *substitute*:
  - "3(4) The Council members shall be appointed by the Council but no fewer than seven shall be selected from the fields of specialisation and work enshrined in the objects of the School.".
- 2. Article 3(6) *delete*: "Unless the Council otherwise determines, no Council member shall be elected or re-elected after the age of 70.".
- 3. Insert Article 3(12):
  - "3(12) All or any of the members can take part in a meeting of the Council by way of a conference telephone or any communication equipment which allows everybody to take part in the meeting by being able to hear each of the other people at the meeting and by being able to speak to all of them at the same time. A person taking part in this way will be treated as being present at the meeting and will be entitled to vote and be counted in the quorum. Such a meeting shall be deemed to take place where the largest group of those

participating is assembled or, if there is no such group, where the chairman of the meeting then is.".

### 4. Insert Article 3(13):

"3(13) A resolution in writing passed in accordance with the provisions of this Article shall be just as valid and effective as a resolution passed by those members at a meeting of the Council which is properly called and held. A resolution in writing must be signed by all of the members who at the time are entitled to receive notice of a meeting of the Council and who would be entitled to vote on the resolution at a meeting of the Council, and who together meet the quorum requirement for a meeting of the Council. The resolution can be passed using several copies of the resolution if each copy is signed by one or more members."

## '§ 200. Part 72: Basant Kumar and Sarala Birla Graduate Scholarship Fund

- 1. The benefaction from Birla International Limited of eight hundred and fifty one thousand pounds (£851,000), together with any further donations for this purpose, shall be known as the Basant Kumar and Sarala Birla Graduate Scholarship Fund for the Support of Graduate Study in Linguistics, Philology and Phonetics.
- 2. The University shall retain all of the Fund as permanent endowment and shall apply the net income of the Fund towards the Basant Kumar and Sarala Birla Graduate Scholarship in the Faculty of Linguistics, Philology and Phonetics.
- 3. The administration of the Fund, and the application of its income, shall be the responsibility of the Board of the Faculty of Linguistics, Philology and Phonetics.
- 4. The Scholarships shall be open to students from any country of residence who are undertaking graduate <u>study or research in Linguisties</u> in the Faculty of Linguistics, Philology and Phonetics.
- 5. The Fund may be used to provide one or more Scholarships in any year. Each Scholarship may will-provide full funding for the standard duration of the student's course (typically three years in the case of doctoral students), or may provide partial funding. It is anticipated that one scholarship will be held at any one time.
- 6. The University will not offer a Scholarship until such time as the net income accumulates to the point where adequate funds become available to fund a student for the full duration of his/her course.
- 76. Regulations Sections 3, 4, and 5 and 6 may be amended by Council.'
