AMENDMENTS TO THE CHARTER OF QUEEN MARY AND WESTFIELD COLLEGE,  
UNIVERSITY OF LONDON

1. In Article 1:
  - a) after "Queen Mary" *delete* "and Westfield College,";
  - b) after "referred to as" *delete* "the College" and *substitute* "QMUL and previously named Queen Mary and Westfield College, University of London from 1989 to 2013".
2. Wherever it occurs in the Charter *delete* "the College" and *substitute* "QMUL".
3. In Article 3 *delete* "and Statutes".
4. In Article 10(a) *delete* the second iteration of "four years".

AMENDMENTS TO THE CHARTER OF THE CHARTERED INSTITUTE OF LEGAL  
EXECUTIVES

1. **Delete** Article 2 and **substitute**:

"2. The objects for which the Chartered Institute is incorporated are:

- (a) To serve the public interest by promoting and maintaining proper standards of ethical conduct, efficiency and training on the part of Fellows and other members of the Chartered Institute, whether by acting as an approved regulator under the Legal Services Act 2007 (The Act) or otherwise.
- (b) To serve the public interest by acting as an approved regulator under the Act, so far as designated by the Lord Chancellor to do so, in respect of persons (not being Fellows or members of the Chartered Institute) and entities carrying on, or seeking to carry on, reserved legal activities within the meaning of Section 12 of the Act.
- (c) To serve the public interest by acting as a qualifying regulator under Schedule 18 to the Act, so far as approved by the Legal Services Board to do so, in respect of Fellows and members of the

Chartered Institute, and other persons and entities, providing, or seeking to provide, immigration advice and services.

- (d) To serve the public interest by exercising such other functions relating to the grant of regulatory approvals under the Act as may be conferred from time to time.
- (e) To provide for the education and training, and developing the proficiency, of Fellows and those who wish to become proficient in the law, including those persons seeking to qualify as Fellows, in all subjects and skills, whether in the law or otherwise.
- (f) To enhance and maintain public confidence in the work of Chartered Legal Executives and other persons and entities regulated by the Chartered Institute within the administration of justice and the service of clients.
- (g) To promote in the public interest co-operation and mutual assistance amongst persons employed in the legal profession or engaged in legal work.”

2. In Article 3 (j):

- (i) after “other persons” *insert* “and entities”;
- (ii) after “registered with” *insert* “or regulated by”.

3. After Article 10 *insert*:

“10A. Persons (not being Fellows or members) regulated (either directly or as managers of entities) under Article 2(b) or Article 2(c) may participate in the activities of the Chartered Institute as decided by the Council.”

4. At the end of Article 11 *insert*:

“Each applicant (not being a Fellow or member) for –

- (a) authorisation by the Chartered Institute to carry on reserved legal activities;
- (b) authorisation by the Chartered Institute to provide immigration advice and immigration services; or
- (c) any other form of regulatory approval

shall be taken to agree if authorised or approved to be bound by this Our Charter and the Bye-Laws.”

AMENDMENTS TO THE CHARTER OF THE ARTS COUNCIL OF ENGLAND

1. In the second paragraph of the preamble:
  - (a) after "to give effect to" **insert** "revised and";
  - (b) after "arrangements for" **delete** "regionalisation of".
2. In Article 3:
  - (a) **re-number** Articles 3(3) to 3(11) as 3(4) to 3(12).
  - (b) **insert** new Article 3(3)

"(3) "**Code**" means a document which sets out the standards and principles of conduct expected of members of the Council;"
  - (c) **delete** the re-numbered Article 3(6) and **substitute**:



“(6) “**Area Council**” means an Area Council of the Council established under Article 11;”.

(d) In the re-numbered Article 3(8) after “or such of Our Ministers as for the time being is responsible for the arts” *insert* “, museums and libraries”.

3. *Delete* “Regional” in sub-Articles 5(1); 5(5); 6(5); 7(1)(b); 7(2); 7(3); 7(4); 7(5); 11(1); 11(2); 11(2)(a); 11(2)(b); 11(3); 11(4) and *substitute* “Area”.

4. In Article 5(5):

(a) after “the funding of” *delete* “their administration and”;

(b) after “activities” *insert* “in each geographical area from time to time covered by an Area Council”.

5. *Delete* Article 6(4) and *substitute*:

“(4) loans, grants or other payments to any organisation, individual, or supplier of goods or services made in accordance with regulations in pursuance of the objects, notwithstanding that any member of the Council may have a connection to such organisation, individual or supplier of goods or services which may confer an indirect financial benefit on that member of Council provided that:

(a) such a payment is in the best interests of the Council;

(b) any member of the Council in receipt of such benefit complies with the Code;

(c) the number of members of Council in receipt of any such material indirect benefit does not constitute more than two thirds of the Council in any financial year (commencing 1 April in each year).”.

6. In Article 7(1)(b), after “The Council shall consist of” *delete* “the members of the Arts Council of England as constituted under the Charter of 1994 until such time as the Chairs of the Regional Council have been appointed, from which time it shall consist of”.

7. After Article 7(1)(c) *delete* “not exceed fifteen,” and *substitute* “consist of fourteen,”.

8. In Article 9(1) after “and the quorum shall be” *delete* “eight” and *substitute* “seven”.

9. In Article 11(1) after “There” *delete* “shall” and *substitute* “may”.

10. In Article 11(2):

(a) after “shall consist of” ***delete*** “fifteen” and substitute “twelve”;

(b) after “or such” ***delete*** “higher” and substitute “other”.

11. In Article 11(3):

(a) in “the Council shall delegate”, ***delete*** “shall” and ***substitute*** “may”;

(b) in Article 11(3)(a) after “determine spending plans for submission to” ***insert*** “and approval by”;

(c) ***delete*** Article 11(3)(b) and substitute:

“(b) determine Area strategies, plans and priorities for submission to and approval by the Council;”;

(d) ***delete*** Articles 11(3)(c) to 11(3)(h).

1. *Delete* Article 10 and *substitute*:

“10. There shall be a President and one or more Vice Presidents of the Institute.”.

2. In Article 11 *delete* “Vice President” each time it occurs and *substitute* “Vice President(s)”.

3. In Article 23:

(a) *delete* “a print” and *substitute* “an electronic”;

(b) *delete* “a list” and *substitute* “an online list”.

The provisions of the Act relating to the making of the Ordinance have been complied with.

The said Ordinance has been referred to the Scottish Universities Committee of the Privy Council, who have reported to Her Majesty that in their opinion the said Ordinance may properly be approved.

Therefore, Her Majesty, having taken the said Ordinance into consideration, is pleased, by and with the advice of Her Privy Council, to approve it.

ORDINANCE of the UNIVERSITY COURT of the  
UNIVERSITY OF ABERDEEN  
NO. 143 [ELECTION OF THE CHANCELLOR AND ELECTION OF  
GENERAL COUNCIL ASSESSORS TO THE UNIVERSITY COURT]

At Aberdeen, the 25th day of September Two Thousand and Twelve

WHEREAS the Universities (Scotland) Act 1966, section 3(1) and Schedule 2, Part I, paragraph 3, empowers the University Court to fulfil the purposes, *inter alia*, of section 14 of the Universities (Scotland) Act 1889, and section 14(4) of that Act includes as one of the purposes *inter alia* to regulate the time, place and manner of presenting and electing University officers;

AND WHEREAS the Universities (Scotland) Act 1966, section 3(1) and Schedule 2, Part I, paragraph 1, empowers the University Court to amend the composition, powers and functions *inter alia* of the University Court and the General Council;

AND WHEREAS the University Court deems it expedient to alter the arrangements relating to the election of a Chancellor of the University of Aberdeen, as presently governed by University Court Ordinance No.123 (General Council: Regulations for Election of Chancellor) as amended by University Court Ordinance No.124 (General Council: Regulations for Election of Chancellor), and to alter the arrangements for the election of General Council Assessors to serve on the University Court, as presently governed by University Court Ordinance No.120 (General Council: Regulations for the Election of Assessors to the University Court) as amended by University Court Ordinance No.125 (General Council: Regulations for the Election of Assessors to the University Court) and University Court Ordinance No. 126 (General Council: Regulation for the Election of Assessors to the University Court).

THEREFORE the University Court, in exercise of the powers conferred upon it by section 3 of, and paragraphs 1 and 3 of Part I of Schedule 2 to, the Universities (Scotland) Act 1966 and of all other powers enabling it in that behalf, hereby statutes and ordains:

PART I

ELECTION OF CHANCELLOR

1. The Chancellor shall be elected for life by members of the General Council whose details are contained within the General Council Register. The election shall be by means of a single transferable vote system. The election shall be conducted in accordance with this Ordinance and arrangements determined from time to time by the Business Committee of the General Council.
2. When a vacancy occurs in the office of Chancellor, the Clerk to the General Council shall fix the date by which nominations for a successor shall be received, hereinafter called the nomination day, such date to be no fewer than

90 days from the date of the vacancy occurring. The Clerk to the General Council shall intimate the nomination day and the conditions for the nomination of candidates in accordance with arrangements determined from time to time by the Business Committee of the General Council. No person who is a member of staff of the University of Aberdeen or who is a matriculated student of the University of Aberdeen shall be eligible for nomination for election as Chancellor.

3. The result of the election shall be transmitted to the Secretary to the University Court by the Clerk to the General Council as soon as that result is established and the University shall publish the said result.

## PART II

### ELECTION OF GENERAL COUNCIL ASSESSORS

4. In the ordinary course and rotation, two Assessors shall be elected to the University Court every two years by members of the General Council whose details are contained with the General Council Register, other than those members of the General Council who are also members of the Senatus Academicus of the University of Aberdeen. The election shall be by means of a single transferable vote system. The Assessors shall be elected in accordance with this Ordinance and the arrangements for the election of General Council Assessors as determined from time to time by the Business Committee of the General Council.
5. Only members of the General Council can be nominated for election as a General Council Assessor. No member of the Senatus Academicus or member of staff of the University of Aberdeen or a matriculated student of the University of Aberdeen shall be eligible for nomination for election as a General Council Assessor notwithstanding that they may be a member of the General Council.
6. A General Council Assessor shall be elected to serve for a term of four years, or such lesser term as may be prescribed by the University Court in accordance with section 2(3) of the Universities (Scotland) Act 1966. A General Council Assessor shall only be eligible for nomination for re-election as a General Council Assessor for one further term of office (whether consecutive or not).
7. In the case of a vacancy for a General Council Assessor arising from the resignation, death or legal incapacity of an Assessor or upon an elected Assessor becoming a member of the Senatus Academicus, a member of staff of the University of Aberdeen or a matriculated student of the University of Aberdeen, the Business Committee of the General Council shall determine the appropriate course of action to fill the vacancy.

8. The result of an election shall be transmitted to the Secretary to the University Court by the Clerk to the General Council as soon as it is established and the University shall publish the said result.

### PART III

#### VALIDITY OF AN ELECTION

9. The validity of any election held in terms of this Ordinance shall not be affected by any defect in the procedure in carrying out such an election unless, on the application of a candidate or an individual designated as a candidate's representative made to the Clerk to the General Council prior to the results of the election being declared, the Convener or Acting Convener of the Business Committee of the General Council, after due enquiry, declares the election to be invalid.

### PART IV

#### INCAPACITY OF CLERK TO THE GENERAL COUNCIL

10. If the Clerk to the General Council is incapacitated by illness or otherwise from discharging the duties in reference to an election imposed by this Ordinance, or if the office of Clerk to the General Council is vacant, the Convener of the Business Committee of the Council shall appoint a person to discharge such duties only in so far as the purposes of the election are concerned, and the person so appointed shall act as, and be deemed to be, the Clerk to the General Council for the purposes of the election.

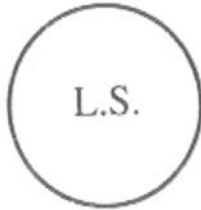
#### REVOCATION OF ORDINANCES

11. On the date on which this Ordinance comes into force, University Court Ordinance No.123 (General Council: Regulations for Election of Chancellor), University Court Ordinance No.124 (General Council: Regulations for Election of Chancellor), University Court Ordinance No.120 (General Council: Regulations for the Election of Assessors to the University Court), University Court Ordinance No.125 (General Council: Regulations for the Election of Assessors to the University Court) and University Court Ordinance No. 126 (General Council: Regulations for the Election of Assessors to the University Court) are revoked.

COMMENCEMENT

12. This Ordinance shall come into force on the date on which it is approved by Her Majesty in Council.
