AMENDMENTS TO THE CHARTER OF THE GUIDE ASSOCIATION

1. In Article 2:

- (a) in 2(v), *delete* "the duties of home keeping mothercraft and citizenship generally and in handicrafts and technical knowledge" and *substitute* "Girlguiding programmes";
- (b) in 2(vi), *delete* "whether by means of apprenticeship or emigration or in any other manner";
- (c) **delete** 2(xiv) and **substitute**:
 - "(xiv) To invest the Association's money not immediately required for its objects in or upon any investments, securities or property and to arrange for investments and other property of the Association to be held in the name of a nominee or nominees and pay any reasonable fee required;".

2. In Article 3:

(a) in 3(i) after "think fit" insert "including the appointment of Vice Presidents";

- (b) in 3(ii) *delete* "As from the Annual General Meeting of the Council of the Association and subject to the transitional provisions contained in the Bye-Laws the" and *substitute* "The".
- 3. In Articles 4 and 6 delete "Ordinary" wherever it occurs and substitute "Annual".
- 4. In Article 5 *delete* "President" *substitute* "Board of Trustees".

SCHEDULE

AMENDMENTS TO THE CHARTER OF THE UNIVERSITY OF LEEDS

- In Article V *delete* "Subsequent appointments to the said office shall be made by the Court on the nomination of the Council for such periods not exceeding three years at a time as may be agreed by the Court on the recommendation of the Council." and *substitute* "Subsequent appointments to the said office shall be made by the Council for such periods not exceeding three years at a time as may be agreed by the Council.".
- 2. In Article VI *delete* "On the recommendation of the Council, the Court may designate" and *substitute* "The Council may designate".
- 3. **Delete** Article X and **substitute**:

"X. The Court

There shall be a Court which shall have the following powers:

- 1. To ask questions about, and to express an opinion on, any matter whatsoever relating to the University; and to convey such opinions to the Council and other University authorities.
- 2. To appoint the Chancellor and the Chair of Court (if not Chancellor or Pro-Chancellor).

- 3. To co-opt members to serve on the Court in accordance with provisions set out in the Statutes and Ordinances.
- 4. To award honorary degrees of the University.
- 5. To establish such committees as it considers necessary to advise it on the discharge of its powers.".
