AMENDMENTS TO THE SUPPLEMENTAL CHARTER OF THE CHARTERED  
INSTITUTE OF PUBLIC FINANCE AND ACCOUNTANCY

- 1) In Article 4(d),
  - (i) after '(with or without prior examinations) to' *delete* 'members of the Institute and' and *substitute* 'persons elected or registered by the Institute and members';
  - (ii) after 'provided also that no' *delete* 'member' and *substitute* 'person elected or registered by the Institute'.

- 2) In Article 4(e), after 'certificates to' *delete* 'Members (as defined under Articles 6 and 7)' and *substitute* 'qualified accountant Members'.
- 3) In Article 4(h), after 'ideas amongst, the' *delete* 'members' and *substitute* 'persons elected or registered by the Institute'.
- 4) *Delete Article 5 and substitute –*  

'5 The Institute shall not carry on any trade or business or engage in any transactions with a view to the pecuniary gain or profit of the persons elected or registered by the Institute. No such person shall as such have personal claim on any property of the Institute and no part of the income or property of the Institute shall be paid or transferred directly or indirectly by way of dividend or bonus or otherwise howsoever by way of profit to any such persons; provided that nothing herein contained shall prevent the payment in good faith of remuneration to any Officers or servants of the Institute or to any persons elected or registered by the Institute in return for service rendered to the Institute or the payment in good faith of expenses incurred by any such persons or the payment of interest upon money borrowed from any such persons or any payment becoming due under or by virtue of any indemnity given by the Institute to any staff of the Institute or to any persons elected or registered by the Institute in accordance with the Bye-Laws or the payment in good faith of expenses incurred by or moneys deemed payable to any person elected or registered by the Institute or any other person in connection with disciplinary proceedings or the incorporation of, or acquisition of all or any part of the capital of, any company limited by shares or the participation as a member in any company limited by guarantee and not having a share capital (in each case being a company which may or shall carry on any trade or business).'
- 5) *Delete Articles 6 and 7 and substitute the following -*  

'6 There shall be one class of qualified accountant members termed "Members" of the Institute.

7 There shall in addition be the following classes of persons:

  - (a) Affiliate members and Associate members who shall be registered if satisfying such requirements as may from time-to-time be prescribed by or pursuant to the Bye-Laws and regulations of the Institute in respect of training and examinations;
  - (b) Honorary members to whom, save as so provided, the provisions of this Our Supplemental Charter and the Bye-Laws and regulations of the Institute shall not apply.
  - (c) Registered Students who shall be registered if satisfying such requirements as may from time-to-time be prescribed by or pursuant to the Bye-Laws and regulations of the Institute.'
  - 6) In Article 8,
    - (i) where it appears twice, *delete* 'the members' and *substitute* 'every class of person elected or registered by the Institute';

- (ii) after 'proceedings brought against the' *delete* 'member' and *substitute* 'person';
  - (iii) after 'the qualifications for membership' *insert* 'and registration';
  - (iv) after 'terms of election,' *insert* 'registration,'.
- 7) In Article 9,
  - (i) after 'membership of the Institute' *insert* 'as a qualified accountant Member'.
  - (ii) after 'his' *insert* 'or her'.
- 8) In Article 10, *delete* 'member' and *substitute* 'Member or Honorary member or registered as an Affiliate member or Associate member or Registered Student'.
- 9) In Article 11,
  - (i) after 'the abbreviation "CPFA"', *insert* 'or, where such designation is not permitted by local laws, the designation "Public Finance Accountant" and by the use of the abbreviation "PFA" or such other designation and abbreviation as shall be permitted under local laws.';
  - (ii) *delete* 'No other Member of the Institute shall, by virtue of his membership, be entitled to use a designation or abbreviation.'.
- 10) In Article 12,
  - (i) *delete* 'member' and *substitute* 'class of person elected or registered by the Institute';
  - (ii) *delete* 'himself' and *substitute* 'him or herself';
  - (iii) after 'by his' *insert* 'or her'.
- 11) *Delete* Article 15.
- 12) In Article 19, after 'his' *insert* 'or her'.
- 13) In Article 27, after 'paid or distributed among the' *delete* 'members of' and *substitute* 'persons elected or registered by'.

AMENDMENTS TO THE CHARTER OF THE UNIVERSITY OF SURREY

1. In Article 1 -

- (a) Delete "Academic Staff" and substitute "Employees"
- (b) Delete "Graduates of the University" and substitute "Alumni, the Emeritus Professors and holders of other emeritus titles,"

2. In Article 3 -

- (a) in paragraph (3) delete "the General Entrance Requirements of the University and".
- (b) in paragraph (4) add a new second paragraph "These powers shall also extend to any collaborative arrangement with other institutions for the award of joint degrees, diplomas and certificates."

(c) in paragraph (5) delete “Degrees or other academic”

(d) in paragraph (6) delete “academic”

(e) in paragraph (8):

(i) delete “to recognise selected members of the staffs thereof as teachers of the University,”

(ii) add “, all” after “in the University”

(f) in paragraph (11):

(i) add “and” after “academic”

(ii) delete “and domestic”

(g) in paragraph (16) delete “conduce to” and substitute “promote”

### 3. In Article 6 -

Delete “the Federal Senate (while that statutory body exists), and whatever” and substitute “the Executive Board (or such”); and insert close bracket after “executive body”

### 4. In Article 12 -

Delete “working” and substitute “performance”

### 5. In Article 14 -

Delete “this Our Charter and the Statutes, be the governing body of the University in all academic matters, including teaching and research in the University and the regulation and superintendence of the education and conduct of the Students of the University.” and substitute “the Charter and Statutes, have overall responsibility for the regulation of academic matters, including teaching and research, for academic quality assurance and standards, and for the welfare and conduct of students in academic matters.”

### 6. In Article 15 -

Delete Article 15 and substitute:

“There shall be an Executive Board of the University (in this Our Charter called the ‘Executive Board’ or its successor in title) which, subject to the powers of the Council and of the Senate as provided in this Our Charter and Statutes, shall be the principal executive body of the University.”

### 7. Add new Article 16 -

“It shall be the duty of the Council to refer to the Senate and to the Executive Board any matter coming before the Council which the Council considers to fall within the powers and functions of the Senate and the Executive Board. Likewise, it shall be the duty of the Senate and the Executive Board to bring before the Council matters which they consider to fall within the powers and functions of the Council.”

9. Re-number existing Article 16 as Article 17.

In Article 17, as re-numbered -

(a) Delete “Departments” and substitute with “The academic activities”.

(b) Delete “For each such group there shall be an Academic Board of the University. The constitution, powers, functions and membership of Academic Boards shall be prescribed by the Statutes.”

10. Delete existing Article 17.

11. In Article 18 -

Delete “consisting of all the members of the Academic Staff of the University and the holders of such other posts as may be prescribed by Ordinance.” and substitute “the membership of which shall be prescribed by Ordinance”.

12. In Article 20 -

(a) after “Council” delete “and” and insert a comma;

(b) add “and the Executive Board” after “Senate”.

13. In Article 24 -

(a) in paragraphs (1) and (2) -

(i) after “status” add “and” and delete the comma;

(ii) delete “and continuance in office”

(b) Delete paragraph (3) and substitute “The constitution and powers of the Court, Council, Senate and the Executive Board”

13. In Article 27 -

After “Senate”, add “or the Executive Board”.

14. In Article 28

(a) delete the paragraph number “(1)” so that this paragraph constitutes Article 28.

(b) delete paragraph (2)

15. In Article 29 -

Delete (1) and substitute "Subject to the provisions of this Our Charter and the Statutes and Ordinances, the Senate and the Executive Board may make such regulations on matters within their purview as each considers necessary for the purposes of carrying out the objects of the University."

16. For Article 30 substitute "The University will not discriminate on grounds of political belief, gender, sexual orientation, disability, age, marital status, race, ethnic origin, religion or belief, social background, or any other factor in respect of which discrimination shall be prohibited by law, against any person in determining whether he or she is to be admitted as a Member of the University or hold office therein or to graduate thereat or shall debar or hinder full enjoyment of the privileges, advantages and facilities provided by the University."

NOW, THEREFORE, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, as follows:

William Matthews shall be, and is hereby, appointed as an ordinary member of the BBC Trust and designated the Trust member for Scotland for the period beginning on 1st January 2011 and ending on 31st December 2014.

No. 141 [AMENDMENT OF POWERS OF THE UNIVERSITY COURT]

At Aberdeen, the Thirtieth day of June, Two Thousand and Ten

WHEREAS the Universities (Scotland) Act 1966, section 3 and Schedule 2, Part I, paragraph 1, empowers the University Court of the University of Aberdeen ("the University Court") to amend its own powers;

AND WHEREAS the University Court wishes to vary or revoke the Ordinance of the University Commissioners, Academic Staff, inserted by the University

Commissioners (Statute Modifications) (University of Aberdeen) Order 1992 (S.I. 1992/2704);

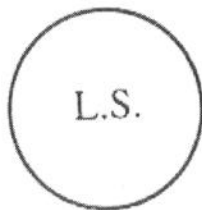
AND WHEREAS the University Court does not have an express power, in terms of section 3 and paragraph 1 of Part I of Schedule 2 to the Universities (Scotland) Act 1966, to vary or revoke the Ordinance of the University Commissioners, Academic Staff, inserted by the University Commissioners (Statute Modifications) (University of Aberdeen) Order 1992 (S.I. 1992/2704);

THEREFORE the University Court in exercise of its powers under section 3 and paragraph 1 of Part I of Schedule 2 to the Universities (Scotland) Act 1966 and of all other powers enabling it in that behalf, hereby statutes and ordains:

1. The University Court shall have the power to vary or revoke, by ordinance, the Ordinance of the University Commissioners, Academic Staff, inserted by the University Commissioners (Statute Modifications) (University of Aberdeen) Order 1992 (S.I. 1992/2704).
2. That variation or revocation may include transitional, saving or consequential provision.
3. This Ordinance shall come into force on the date on which it is approved by Her Majesty in Council.

*SCHEDULE*

ORDINANCE of the UNIVERSITY COURT of the UNIVERSITY OF GLASGOW  
No. 205  
(EMPLOYMENT MATTERS)

At Glasgow, the 13th day of October, Two Thousand and Ten.

WHEREAS the University Court wishes its employment practices to comply with current and future legislation and regulation, with the principles of natural justice and with recognised good practice in relation to discipline, redundancy, grievance, dismissal and other removal from office of staff engaged in teaching, the provision of learning or research;

WHEREAS the University Court recognises its obligations regarding the desirability of ensuring the academic freedom of staff engaged in teaching, the provision of learning or research;

And WHEREAS the University Court wishes to promote equality of opportunity and dignity at work within the University;

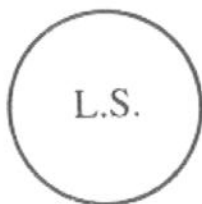
THEREFORE the University Court of the University of Glasgow in exercise of the powers conferred upon it by section 3 of, and paragraph 1 of Part I of Schedule 2 to, the Universities (Scotland) Act 1966, by Ordinance No. 204 and all other powers enabling it in that behalf, statutes and ordains:

1. The Ordinance of the University Commissioners (Academic Staff) inserted by The University Commissioners (Statute Modifications) (University of Glasgow) Order 1992 (S.I. 1992/2698) is revoked.
2. Any regulations and resolutions made by the University Court in relation to the discipline, redundancy, grievances, dismissal and other removal from office of relevant staff must:-
  - (a) be made so as to give effect to the guiding principle that, in their areas of academic expertise, relevant staff employed by the University shall have freedom within the law to hold and express opinion, to question and test established ideas and received wisdom and to present controversial or unpopular points of view without placing in jeopardy their employment or any entitlements or privileges they enjoy;
  - (b) only be made following consultation with the recognised trade unions;
  - (c) include procedures for handling grievances and cases of unsatisfactory conduct, performance or capability (including without limitation through ill health) and for the regulation and termination of contracts (including without limitation through retirement and redundancy);
  - (d) ensure that the University Court retains strategic oversight of the procedures adopted for the redundancy dismissal of staff; and
  - (e) make provision for appeals by relevant staff against grievance or dismissal outcomes to be heard by a panel including a senior member of academic staff, drawn from a grouping proposed jointly by University management and the recognised trade union(s) and approved by the University Court.
3. In this Ordinance, "relevant staff" means any person engaged in teaching, the provision of learning or research in the University.
4. This Ordinance shall come into force after its approval by Her Majesty in Council on a date to be determined by the University Court.

- 4) St Mary Magdalene's Churchyard, Lillington, Leamington Spa, Warwickshire;
- 5) St Mary's Churchyard, Shirehampton, Bristol;
- 6) Churchyard of St Mary the Virgin, Southwell, Nottinghamshire (as shown hatched on the plan annexed hereto).

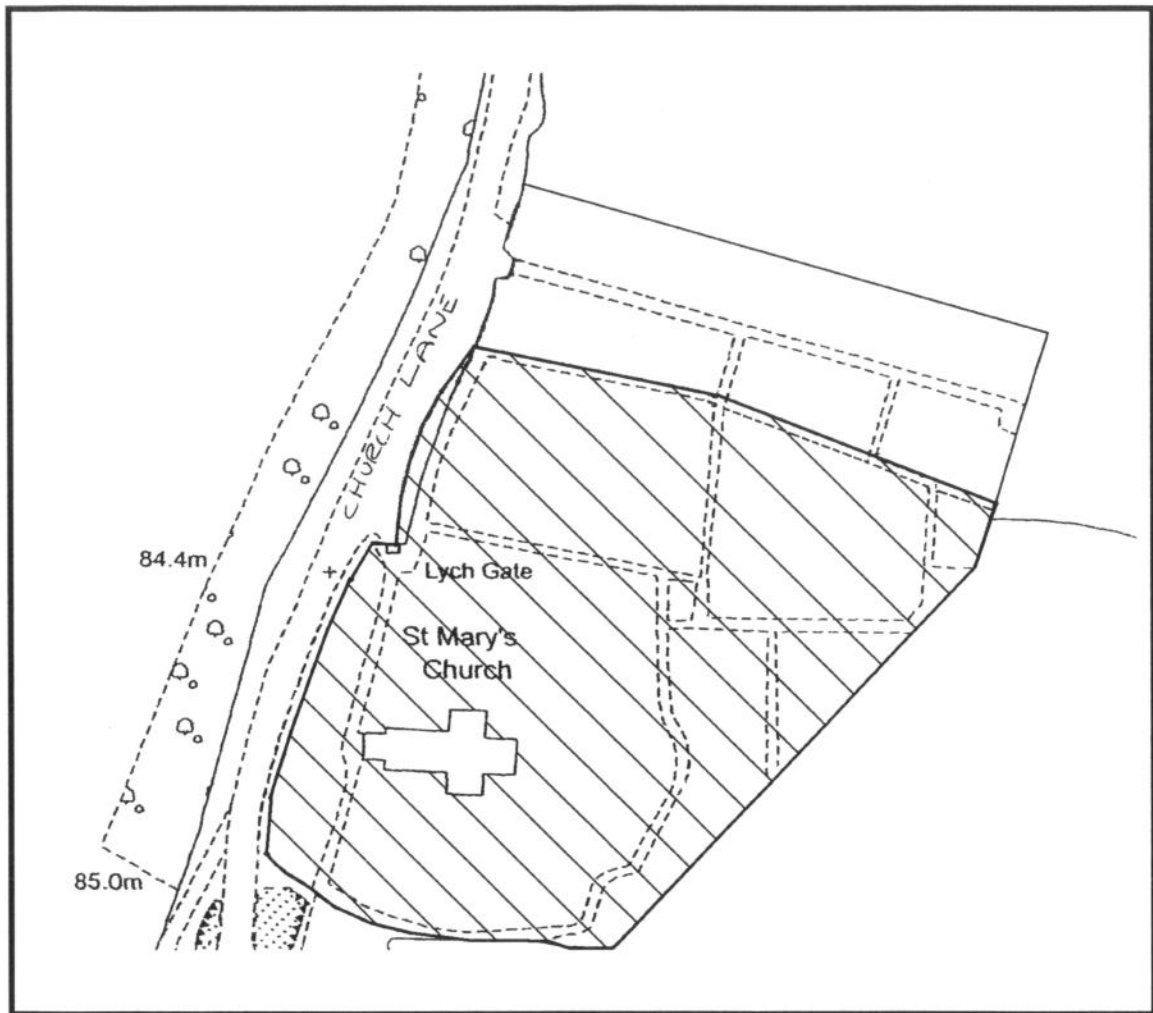
In pursuance of the Order in Council made on 13th October 2010 these representations have been published and taken into consideration by a Committee of the Privy Council.

Accordingly, Her Majesty, in exercise of the powers conferred on Her by section 1 of the Burial Act 1853, is pleased, by and with the advice of Her Privy Council, to order that burials shall be discontinued forthwith in the places listed above, subject to the following exceptions:-

- (a) in the places numbered 1, 3, 4, 5 and 6 above, in any existing earthen grave in the churchyard, the burial may be allowed of the body of any member of the family of the person or persons previously buried in that grave, but no part of the coffin containing the body shall be at a depth less than one metre below the level of the surface of the ground adjoining the grave; and
- (b) in the place numbered 5 above, in any grave space in which no interment has previously taken place, the burial may be allowed of any person for whom, or any member of the family for which that grave space has been reserved and appropriated, with the exclusive right of burial, but no part of the coffin containing the body shall be less than one metre below the level of the surface of the ground adjoining the grave.

- 1) Churchyard of St Michael's and All Angels, Creton, Northamptonshire;
- 2) St James the Great Churchyard, Dauntsey, Nr. Chippenham, Wiltshire (as shown hatched on the plan annexed hereto);
- 3) Churchyard of the Church of the Nativity of the Blessed Virgin Mary, Lympstone, Exmouth, Devon;
- 4) St Mary's Churchyard, Handsworth, Sheffield (as shown hatched on the plan annexed hereto);
- 5) Churchyard of St John the Evangelist, Hedge End, Southampton, Hampshire;
- 6) St Andrew's Churchyard, Paull, East Riding of Yorkshire;
- 7) Holy Trinity Churchyard, Minsterley, Shropshire.

The exceptions are that:-

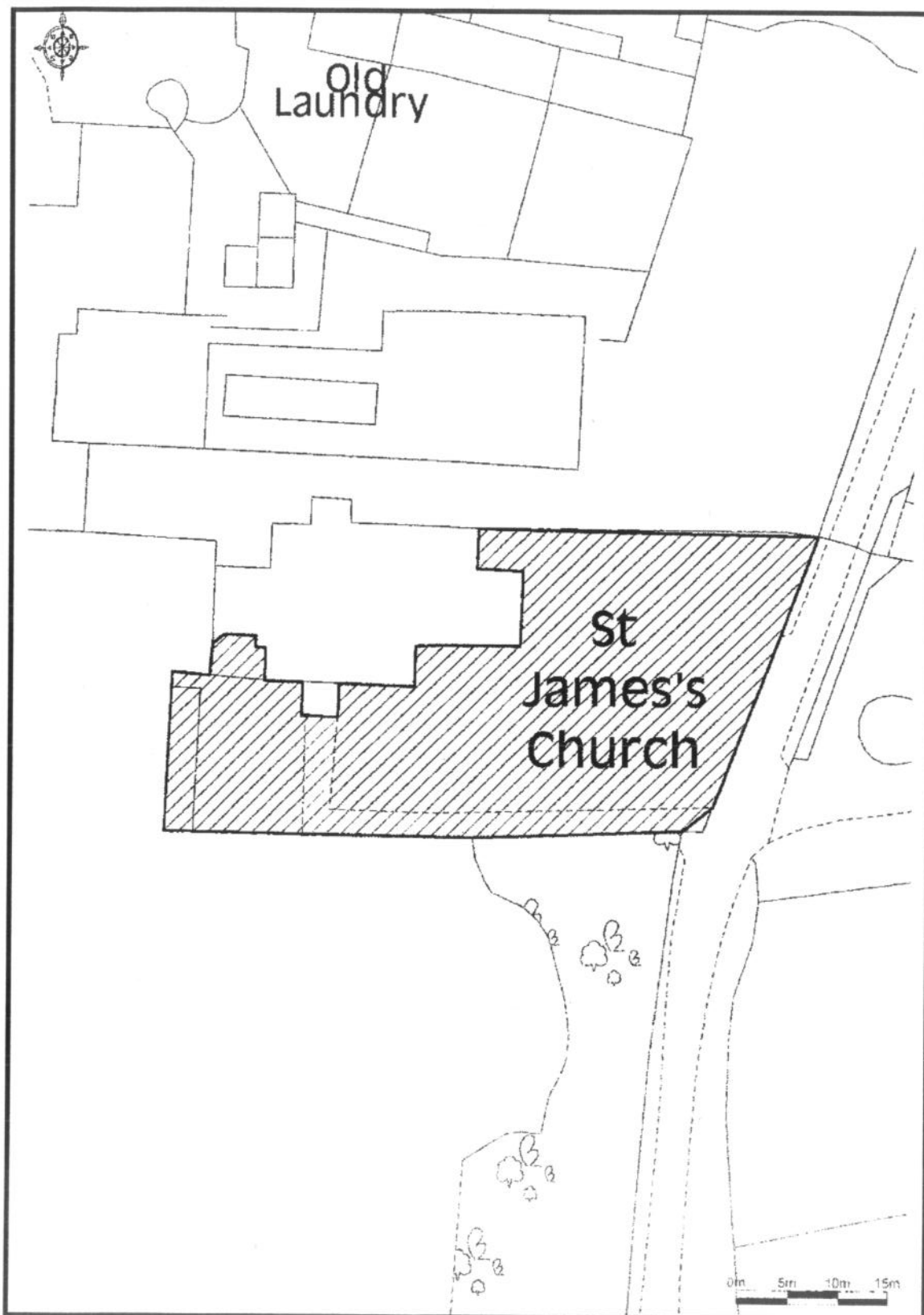
- (a) in the place numbered 3 above, in any vault or walled grave in the churchyard, burial may be allowed but every coffin buried in such vault or grave must be separately enclosed by stonework or brickwork properly cemented; and

- (b) in the places numbered 3, 4, 5 and 6 above, in any existing earthen grave in the churchyard, the burial may be allowed of the body of any member of the family of the person or persons previously buried in that grave, but no part of the coffin containing the body shall be at a depth less than one metre below the level of the surface of the ground adjoining the grave.

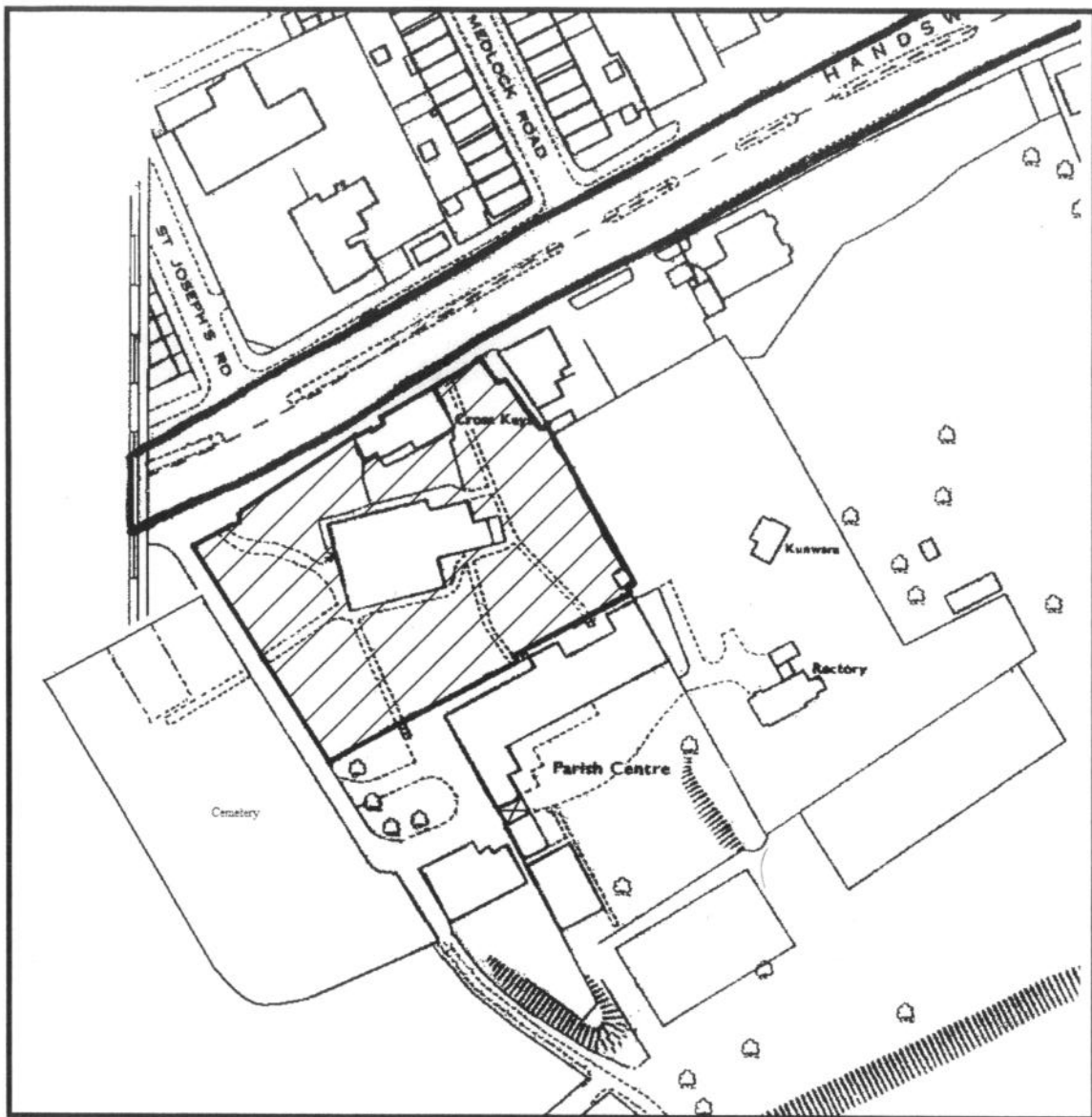
