SCHEDULE

AMENDMENTS TO THE CHARTER OF THE ROYAL COLLEGE OF OBSTETRICIANS AND
GYNAECOLOGISTS

1. These amendments shall come into effect on 3rd June 2013.
2. *Delete* "Council" wherever it occurs in Articles 2, 4(n), 5 and 7 and *substitute* "Board of Trustees".
3. In Article 7 *delete*, "the honorary officers of the College as specified in the Regulations and of up to 32 other members elected and holding office in accordance with Regulations." and *substitute*, "such persons elected or appointed, and holding office, in accordance with Regulations."
4. In Article 10, after "or in default of such direction as the" *delete* "Council" and *substitute* "Board of Trustees".

SCHEDULE

AMENDMENTS TO THE CHARTER OF THE UNIVERSITY OF EXETER

1. In Article 1 after "personal property." *delete* all text to the end of the Article.

2. *Delete* Article 3(e) and *substitute*:

"(e) To grant degrees diplomas certificates or other distinctions in partnership with another institution of similar standing to the University either as a joint, double or multiple award."

3. *Renumber* Articles 4 to 19 as 5 to 20

4. *Insert* new Article 4

"4. The University shall not make any dividend, gift, division or bonus in money to or between any of its members except by way of prize, reward or special grant in accordance with section 13 of the Statutes."

5. In Article 8 as renumbered, *delete* "Convocation,".

6. In Article 9(a) as renumbered, *delete* "and shall preside over meetings of Convocation".

7. In Article 10 as renumbered:

- (a) in Article 10(a) after “he” *insert* “or she”;
- (b) *delete* Article 10(b) and renumber 10(c) to 10(d) as 10(b) to 10(c).

8. In Article 12 as renumbered:

- (a) in Article 12 (a) *delete* “Statutes” and substitute “Ordinances”;
- (b) in Article 12 (b) *delete* “Statutes” and substitute “Ordinances”.

9. In Article 14(a) as renumbered, *delete* “of Arts, Law, Science and Social Studies and such other Faculties either in addition to or substitution for the aforesaid Faculties as” and *substitute* “that”.

10. *Delete* Article 15 as renumbered *substitute*:

“15. Alumni shall have the right to represent their views to the University as provided for in the Statutes and Ordinances.

The University of Exeter agrees that those who meet the following criteria be considered as alumni of the University:

(a) Studied with the University (or the University College of the South West of England) and its component institutions (e.g., St Luke’s College) for at least one academic year, regardless of whether a degree was obtained, or studied at the University either under an exchange agreement, e.g. Erasmus, or participated in the University’s Study Abroad programme.

(b) Studied with the University and its component institutions for normally at least three months, and completed a course which could lead to a degree, certificate, diploma or other qualification.

(c) Honorary Graduates - Other individuals who have a recognized and legitimate affiliation with the University are welcome to request access to alumni benefits, activities and networks. These requests will be reviewed by the Head of Alumni Relations and a decision will be made as to whether access will be granted. In most cases, those with a legitimate previous affiliation as students who also consider themselves to be alumni will be able to access alumni benefits and services. Alumni benefits are also extended to current and former staff of the University, and to former students of the Peninsula College of Medicine and Dentistry.”.

The following report from the Committee of Council for the Affairs of Jersey and Guernsey was today read at the Board:

“In accordance with Your Majesty’s General Order of Reference of 22nd February 1952 the Committee have considered a letter from the Greffier of the States of Jersey transmitting an Act passed on 11th September 2012 entitled the Residential Tenancy (Amendment) (Jersey) Law 2012:

“The Committee have considered the Act and have agreed to report that it may be advisable for Your Majesty to approve and ratify it.”

Her Majesty, having taken the report into consideration, was pleased, by and with the advice of Her Privy Council, to approve and ratify the Act (a copy of which is annexed to this Order) and to order that it, together with this Order, shall be entered on the Register of the Island of Jersey and observed accordingly. Her Majesty’s Officers in the Island, and all others whom it may concern, are therefore to take notice of Her Majesty’s Order and to proceed accordingly.
