SCHEDULE

AMENDMENTS TO THE CHARTER OF THE UNIVERSITY OF SHEFFIELD

1. **Delete** Articles 1 to 27 and **substitute**:

- "1. This Charter constitutes and founds The University of Sheffield ("the University") as a body corporate.
- 2. The objects of the University shall be to advance education through teaching and research ("the Objects").
- 3. The University shall have all the powers of a natural person including but not limited to the following powers, in furtherance of the Objects:
 - (a) To award degrees and other academic awards and to withdraw such awards;
 - (b) To acquire, own, maintain, manage and dispose of land and other property;
 - (c) To solicit, receive and administer fees, charges, grants, subscriptions, donations; endowments, legacies, gifts and loans of any property whatsoever whether land or personal property and any other sources of income;

- (d) To act as trustee for and in relation to endowments, legacies and gifts;
- (e) To invest;
- (f) So far as permitted by charity law, to give guarantees;
- (g) So far as permitted by charity law, to borrow and raise money and give security for loans; and for those purposes the University shall have the authority to enter into any financial instrument which is ancillary or incidental to the exercise of such powers;
- (h) To take such steps as may from time to time be deemed expedient for the purposes of procuring and receiving contributions to the funds of the University and to raise money in such other manner as the University may determine;
- (i) To co-operate and collaborate with other institutions and individuals, award joint degrees or other awards, and affiliate or incorporate into the University any other institution and take over its property, rights, liabilities and staff;
- (j) To enter into engagements and to accept obligations and liabilities in all respects without any restrictions whatsoever and in the same manner as an individual may manage his or her own affairs; and
- (k) To do anything else, whether incidental to these powers or not, in order to further the Objects of the University as a place of teaching and research.
- 4. There shall be a Council of the University which shall be the University's governing body with responsibility for the management of the University and the conduct of all the University's affairs.
- 5. There shall be a Senate of the University which shall, subject to the Statutes and the control and approval of the Council, oversee the teaching and research of the University and the admission and regulation of Students.
- 6. There shall be a Chancellor of the University who shall be the titular head of the University and entitled to confer degrees and other academic awards of the University.
- 7. There shall be a chief executive of the University who shall have the title of Vice-Chancellor or equivalent and who shall be the Chair of the Senate and who shall in the absence of the Chancellor confer Degrees and other academic awards.
- 8. There shall be not fewer than two Pro-Chancellors of the University. The Chair of the Council shall be a Pro-Chancellor by virtue of holding that office.

- 9. There shall be a Students' Union of the University and the University shall take steps to ensure that the Students' Union acts fairly and democratically and is accountable for its finances.
- 10. It is a fundamental requirement of the University to promote equal opportunities and ensure that no unlawful discriminatory test be imposed upon any person in order to entitle them to:
 - (a) become a holder of office at or a member of staff, student or graduate of the University; or
 - (b) receive any advantage or privilege by reason of such position.
- 11. There shall be a Visitor of the University who shall be appointed by the Privy Council from time to time, on the nomination of the Council, from those who hold or who have held high judicial office.
- 12. The University shall take steps to encourage engagement in its activities by the holders of degrees and other academic awards of the University ("the alumni"), including specifically co-operation between the alumni and the Council, to support and advance the Objects.
- 13. The Council may at any time amend or add to this Charter or the Statutes and any such amendments or additions shall take effect when approved by the Privy Council. The Statutes shall prescribe or regulate, as the case may be, the internal management of the University.
- 14. The Council may make Regulations and may amend or repeal Regulations.
- 15. The property and funds of the University shall be used only for promoting the Objects. If the University is dissolved, the assets (if any) remaining after providing for all its liabilities must be applied in one or more of the following ways:
 - (a) by transfer to one or more other bodies established for exclusively charitable purposes within, the same as or similar to the Objects;
 - (b) directly for the Objects or for charitable purposes which are within or similar to the Objects;
 - (c) in such other manner consistent with charitable status as the Privy Council approves in writing in advance.
- 16. In this Our Charter "Statutes" means the Statutes set out in the Schedule and "Regulations" means Regulations made under the powers conferred by this Charter.".

 - 4. One member to be elected by the Council of the Royal Society
 - 5. No fewer than three and not more than twenty members (or such greater number as the Governing Body shall from time to time determine) to be elected by the Governing Body.
 - 6. One member to be elected under the regulations made by the Governing Body by such teaching staff of the Great School as have been on the full-time staff of the School for at least one full year immediately preceding the election of such a member.
- 3. Chapter II Clause 6 of the Statute shall be amended to read as follows:
 - 6. The term of office for an Elective member of the Governing Body shall be five years after which he may if he so wishes stand for re-election.
- 4. Chapter II Clause 7 of the Statute shall be amended to read as follows:
 - 7. An Elective member of the Governing Body shall cease to be a Governor if he:
 - a) be absent from every meeting of the Governing Body during the space of two years; or





Disposal of revenue to be subject to the University Statutes as to College 1 The application of the revenues of the College under the provisions and to the purposes of these Statutes shall be subject to any Statute or Statutes made for the University under the powers of the Universities of Oxford and Cambridge Act 1877 and the Universities of Oxford and

Contributions

Use of Income from endowments and trusts to meet University charges Cambridge Act 1923, for enabling or requiring the Colleges to make contributions out of their revenues to University purposes, and to the payment of the charges imposed thereby.

- **2** (a) Income to which this clause applies may be applied in or towards the payment of any charges for University purposes imposed on the College by any Statute or Statutes made for the University from time to time under the powers of the Universities of Oxford and Cambridge Act 1877 and the Universities of Oxford and Cambridge Act 1923, to the extent to which any such charges are so imposed in respect of any such income.
- (b) This clause applies to income arising from any endowment, benefaction, or trust, and applicable to the maintenance of any Fellowship, Scholarship, or Exhibition within the College, or to any other purpose for the benefit of the College or of the Head or any other member of the College, including any fund for the purchase of advowsons, in every case where the endowment, benefaction, or trust
- (i) was created by an instrument which came into operation not less than sixty years before the thirty-first day of December, nineteen hundred and thirty-seven;
- (ii) is included among the endowments, benefactions, or trusts specified in the Schedule appended to this clause, the Trustees or Governing Bodies whereof have consented to the provisions of this clause.
- (c) This clause shall first apply to the revenue of the College for the year ending the 31st December 1937.

Scheme to be approved by Visitor

3 If at any time it shall appear to the Visitor that the revenues of the College have become more than sufficient to provide for its expenditure, the Visitor may, if he think fit, make an order directing that any part of the surplus revenue shall be set apart and applied to purposes relative either to the College or to the University, according to a scheme submitted or to be submitted to him by the Governing Body and approved by him. After an order so made by the Visitor, any sums thereby directed to be set apart shall be applied in conformity with a scheme submitted to and approved by the Visitor as aforesaid, and under an order of the Visitor confirming the same, and not otherwise.

What included in the expenditure of the College

4 The expenditure of the College shall, in the foregoing section, be deemed to include as well the payment of charges for University purposes imposed by Statutes made for the University as aforesaid, as the application of revenue to the purposes of these Statutes, reasonable and customary expenditure (not inconsistent with them) for College purposes, extraordinary expenditure (when required) on estates, and any reasonable donations either for educational or charitable objects or for purposes connected with the duties of the College as a holder of property.

Communication of the Scheme to Hebdomadal Council

5 Before any scheme is confirmed by the Visitor, the Governing Body shall communicate it to the Vice-Chancellor for the information of the Hebdomadal Council of the University; and the Visitor shall consider any representations which the Hebdomadal Council may judge it expedient for the interests of the University to make with reference to such scheme.

Confirmation of Scheme

6 An order made by the Visitor confirming a scheme submitted to him by the Governing Body shall continue in force until a new scheme varying it or in substitution for it shall have been submitted and confirmed in like manner.

Representation to Visitor

7 The Governing Body or any six members of the Governing Body may at any time make a representation to the Visitor requesting him to exercise, if he think fit, the powers of this Statute. But this provision shall not be deemed to affect the Visitor's right to exercise such powers *proprio motu*.

Surplus Revenue

8 Subject to the right of the Visitor to exercise the powers hereby given to him, any surplus of the revenues of the College shall from time to time be applied by the Governing Body at their discretion to any purposes relative to the College and not inconsistent with these Statutes, or (subject to the Statutes of the University in force for the time being) to any purposes relative to the University and conducive to the advancement of learning, science, or education.

Restrictions on Application of Surplus Revenue 9 No addition shall under the powers of this Statute be made to the emoluments of the Headship, or of any Fellowship, Postmastership, or Open Exhibition in the College; nor to payments from the corporate revenues which may be made under these Statutes to any College Fund in respect of which payments from the corporate revenues are limited by these Statutes, nor to the numbers of Postmasterships or Open Exhibitions. But this section shall not be deemed to prohibit or restrain the College from making payment under the preceding section out of its surplus revenue for research or other work in any department of learning or science, or for the publication of the results of such research or other work.


Accounts

10 It shall be the duty of the Bursars to present annually to the College, and of the Auditor or Auditors or the Finance Committee to certify, a clear statement of the income and expenditure of the College, of the disposable surplus (if any), and of the proposed appropriation of it, together with a statement of the outstanding liabilities other than those relating to current expenditure, specifying the terms within which loans raised under the borrowing powers of the College are to be paid off. This statement shall include trust accounts, as well as the general accounts of the College.

Total Return

11 The Governing Body shall have the power to expend for any purpose within the provisions of the Statutes so much of the value of any fund as is prudent in all the circumstances having regard to the total return achieved and reasonably to be expected in the long term, where 'total return' means return in terms of both income, whether received or accrued, and capital appreciation, whether realised or unrealised, always subject to any specific investment restrictions applicable to trust funds. References to 'income' or 'revenue' elsewhere in this Statute XII shall be deemed to include the value of any fund (as appropriate) referred to in this clause.




