- 1. Roger Carr shall be, and is hereby, appointed as Vice-Chairman of the BBC Trust for the period beginning on 1st May 2015 and ending on 30th April 2019.
- 2. Mark Damazer shall be, and is hereby, appointed as an ordinary member of the BBC Trust for the period beginning on 1st April 2015 and ending on 31st March 2019.

AND whereas by Order in Council dated 30th March 1977 rates denominated in Hong Kong dollars and conditions of awards of service pensions, terminal grants and service gratuities were laid down for Naval ratings locally entered at Hong Kong:

AND whereas it is expedient to provide for the increase of certain pensions granted to Locally Engaged Rating of the Hong Kong Division to correspond with the benefits provided, in the case of civil pensions, by the Pensions (Increase) Act 1971(b), as amended by the Superannuation Act 1972(c):

NOW, therefore Her Majesty, in exercise of the powers conferred upon Her by the said Act of 1865 and all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

- 1. This Order may be cited as the Naval and Marine Pay and Pensions (Hong Kong Locally Engaged Ratings' Service Pensions Increase) Order 2015.
- 2. Subject to the provisions of paragraph 1 of the Schedule to this Order, the pensions granted to Locally Engaged Ratings of the Hong Kong Division shall be increased in accordance with paragraph 2 of the Schedule.

#### **SCHEDULE**

#### PENSION INCREASES

- 1. A pension to which this Schedule relates may be increased provided either that:
  - (a) the pensioner has attained the age of 55 years, or
  - (b) the pension is a widow's pension, or
  - (c) the pensioner was invalided from Naval Service, or
  - (d) the pensioner is permanently incapacitated by physical or mental infirmity from engaging in regular full-time employment.
- 2. The appropriate percentage increase for those currently entitled to receive Pension Increases shall be as follows:-

AMENDMENT TO THE EXISTING STATUTES OF CHRIST CHURCH IN THE UNIVERSITY OF OXFORD, DULY MADE UNDER THE PROVISIONS OF THE UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923, AT A MEETING SPECIALLY SUMMONED FOR THE PURPOSE ON THE TWELFTH DAY OF MARCH 2014, AND PASSED AT THAT MEETING BY THE VOTES OF NOT LESS THAN TWO-THIRDS OF THE NUMBER OF PERSONS PRESENT AND VOTING, AND SUBMITTED TO HER MAJESTY THE QUEEN IN COUNCIL.

#### STATUTE I

In Statute 1 amend Clause 1.(b) as follows:

(b) There are six Residentiary Canonries, and there may be up to two Lay Canonries. Three Four of the Residentiary Canonries are annexed respectively to the Regius Professorships of Divinity, and Moral and Pastoral Theology,

the Lady Margaret's Professorship of Divinity, and the Archdeaconry of Oxford. The person appointed by the Crown to hold the Regius Professorship of Ecclesiastical History or the person appointed to hold the Lady Margaret's Professorship of Divinity shall during the currency of the appointment hold either a Residentiary Canonry or a Lay Canonry.

In Statute 1 amend Clause 1.(d) as follows:

- (d) For the purpose of these Statutes:-
- (i) 'Canons' means the holders for the time being of the Residentiary Canonries referred to in sub-clause (b) of this clause, together with (if a Lay Canon) the Regius Professor of Ecclesiastical History and (if a Lay Canon) the Lady Margaret's Professor of Divinity.

#### STATUTE XIII

In Statute XIII delete Clause 6. and renumber Clauses XIII.7 and XIII.8 as XIII.6 and XIII.7 respectively:

#### 6. Students' membership of Congregation

Any Student not a member of Congregation who is qualified to supplicate for a degree which would entitle him or her to such membership shall supplicate for such degree within one year of becoming so qualified. A Student failing to comply with this provision shall vacate his or her Studentship, unless the Governing Body shall deem it just on special grounds to allow the supplicating for such degree to be postponed for a further period not exceeding, except in the case of ill health, one year.



In Statute XII delete Clause 4:

4. Tenure of office of Dean

The office of Dean shall be tenable until the 30th September immediately preceding the holder's 71st birthday.

#### STATUTE XIII

In Statute XIII amend Clause 5.(b) as follows:

5.(b) A Research Student shall be elected in the first instance for a period not exceeding five years, and may be re-elected for further periods, but no Research Student shall hold a Studentship after his or her retirement date fixed in accordance with clause 8(b) of this Statute unless the Governing Body shall resolve by the votes of not less than two thirds of the number of persons present and voting to extend the tenure of the Studentship for a further period or periods. such other period or periods as the Governing Body shall determine.

In Statute XIII delete Clause 8.(b) (the general provision providing for an age of retirement for Students) and re-number (c) as follows:

- (b) Save as provided in clause 5(b) of this Statute and in Statute XVI.3(a)(i), a Student, other than one admitted under clause 3(a) of this Statute, shall vacate his or her Studentship on the 30th September immediately preceding his or her 66th birthday.
- (e)(b) A Student admitted under clause 3(a) of this Statute or elected under clause 3(b) (i), (ii) or (iv) of this Statute shall vacate his or her Studentship on ceasing to hold any Office in the University or in the House in virtue of which he or she was admitted or elected to the Studentship.

#### STATUTE XVI

In Statute XVI amend Clause 3.(a)(i) as follows:

- 3. Particular Officers
- (a) The Treasurer, the Steward, the Librarian and the Curator of Pictures

(i) These Officers, if not already Students, may be elected to Ordinary Studentships under Statute XIII.3(b)(i). They shall not continue in office after the 30th September immediately preceding their 66th birthday unless the Governing Body shall resolve by the votes of not less than two-thirds of the number of persons present and voting to extend their tenure of office. They may be elected or re-elected as Ordinary Students for their tenure of office during such period or periods.

#### STATUTE XVII

In Statute XVII amend Clause 1, as follows:

### 1. Lecturers

The Governing Body may appoint Lecturers and shall have power to terminate such Lectureships when it thinks fit. The salaries of Lecturers and other conditions as to work and residence shall be determined by the Governing Body. No Lecturer shall be appointed or shall continue in office after the 30th September immediately preceding his or her 66th birthday, unless the Governing Body shall resolve by the votes of not less than two-thirds of the number of persons present and voting so to appoint or renew for a period or periods.

#### STATUTE IX

In Statute IX amend as follows:

The Governing Body may from time to time make, amend and repeal By-laws, not inconsistent with these Statutes, in order to give effect to the Statutes or to provide for any matter not provided for in the Statutes. The By-laws shall be binding on all members of the Governing Body, all Lecturers, Research Fellows and Senior Scholars, all Officers of the House and all members of the House in statu pupillari.


