- the other half of the income, or such part thereof as in each year may be found requisite, shall be devoted to the payment of the whole or part of such tuition fees as may be exigible in respect of students enrolled to study at Scottish Universities as may be approved by the Trustees from students of Scottish birth or extraction or scholars who have undertaken two years' full-time (or equivalent) study at secondary education level at such schools, colleges and institutions in Scotland as are subject to inspection or review by Education Scotland. They must have satisfied the qualification for entry and have been accepted for admission to one of the Scottish Universities with a view to graduation with a degree of at least Bachelor level. They shall make application for the payment of their tuition fees in such form as may be prescribed by the Trustees. The decision of the Trustees in all questions of qualifications shall be final. and the tuition fees of all applicants declared to be eligible shall in each case be paid, in whole or in part, by the Trust as they become due to the factors or authorised officers of the Universities. If the Trustees after due enquiry are satisfied that any student has shown exceptional merit at the University, and may advantageously be afforded assistance beyond the payment of such tuition fees, they shall have the power to extend such assistance either in money or other privileges upon such conditions and under such regulations as they may prescribe. They shall also have power to withhold payment of fees from any student who is guilty of misconduct, or who fails within a reasonable time to pass the examinations required by the University for continuation of his or her studies. Any surplus remaining in any year from the income applicable to this head of expenditure may be applied to sub-paragraph (a) of this Article, the first head of expenditure. Colleges, schools or classes in Scotland, attendance at which (full-time or part-time) is recognised as qualifying or assisting to qualify for graduation at a Scottish University, shall, on application, be entitled to participate under sub-paragraph (a) of this Article to such an extent as the Trustees may from time to time determine, and the students thereof shall be admitted to the privileges of this sub-paragraph of this Article. In the case of schools or institutions in Scotland established to provide technical or commercial education the Trustees may recognise classes, which, though outside the present range of the University curriculum, can be accepted as doing work of a University level, and may allow them and the students thereof to participate under both sub-paragraph (a) and this sub-paragraph of this Article to such an extent as the Trustees may from time to time determine;".

There shall be a Curator of the Fielding Herbarium who shall be appointed by the Fielding Curators, who shall also have power to dismiss the curator.

The curator shall be under the direct control of the Sherardian Professor of Botany. He or she shall take charge of the Fielding Herbarium and of other similar collections belonging to the University, and shall supervise the Botanical Library.

The curator shall receive by way of stipend the income derived from the sum of £900 bequeathed to the University by Mrs. Fielding. The Fielding Curators shall have power to increase the stipend of the Curator of the Fielding Herbarium, on the recommendation of the Sherardian Professor of Botany out of the funds at their disposal.'

The following report from the Committee of Council for the Affairs of Jersey and Guernsey was today read at the Board:

"In accordance with Your Majesty's General Order of Reference of 22nd February 1952 the Committee have considered a Petition of the Chief Pleas of the Island of Sark:

"That, in pursuance of their Resolution of 15th April 2015, the Chief Pleas of the Island of Sark at a meeting on 8th July 2015 approved a Projet de Loi entitled the Direct Taxes (Sark) (Amendment) Law, 2015. That the Projet de Loi is as set forth in the attached Schedule. The Petition most humbly prays that Your Majesty might be graciously pleased to sanction the Direct Taxes (Sark) (Amendment) Law, 2015, and to order that it shall have force of law in the Island of Sark.

"The Committee have considered the Projet de Loi and have agreed to report that it may be advisable for Your Majesty to approve and ratify it."

Her Majesty, having taken the report into consideration, was pleased, by and with the advice of Her Privy Council, to approve and ratify the Projet de Loi (a copy of which is annexed to this Order) and to order that it, together with this Order, shall have the force of law in the Island of Sark and shall be entered on the Register of the Island of Guernsey and observed accordingly.

Her Majesty's Officers in the Bailiwick of Guernsey, and all others whom it may concern, are therefore to take notice of Her Majesty's Order and to proceed accordingly.

The Secretary of State for Justice, after giving ten days' notice of his intention to do so, has, under the Burial Act 1853 as amended, made representations to Her Majesty in Council that, subject to the exceptions below, burials should be discontinued in:-

- 1) All Saints Churchyard, Hordle, Lymington, Hampshire;
- 2) St Margaret's Churchyard, Bentham, North Yorkshire (as shown hatched on the plan annexed hereto);
- 3) St Peter and St Paul's Churchyard, Uplyme, Devon (as shown hatched on the plan annexed hereto);
- 4) St Mary's Churchyard, Peldon Road, Great Parndon, Harlow, Essex (as shown hatched on the plan annexed hereto);
- 5) St Peter's Churchyard, Tadley, Hampshire;
- 6) Christ Church Cemetery, Linthwaite, Huddersfield, West Yorkshire (as shown hatched on the plan annexed hereto);
- 7) St Mary The Virgin Churchyard, Ideford, Devon (as shown hatched on the plan annexed hereto);
- 8) Churchyard of St John the Evangelist, Great Stanmore, Church Road, Stanmore, Middlesex (as shown hatched on the plan annexed hereto);
- 9) St John's Churchyard, Newton-on-Rawcliffe, Pickering, North Yorkshire (as shown hatched on the plan annexed hereto);

- 10) St Peter and St Paul Churchyard, Pickering, North Yorkshire (as shown hatched on the plan annexed hereto);
- 11) St Nicholas Churchyard, Porton, Wiltshire (as shown hatched on the plan annexed hereto).


#### The exceptions are that:-

- in the places numbered 2, 3, 4, 5, 6, 7, 8, 9, 10 and 11 above, in any vault or walled grave in the churchyard, burial may be allowed but every coffin in such vault or grave must be separately enclosed by stonework or brick work properly cemented;
- (b) in the places numbered 2, 3, 4, 5, 6, 7, 8, 9, 10 and 11 above, in any existing earthen grave in the churchyard, the burial may be allowed of the body of any member of the family of the person or persons previously buried in that grave, but no part of the coffin containing the body shall be less than one metre below the level of the surface of the ground adjoining the grave; and
- (c) in the places numbered 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 and 11 above, in any grave space in which no interment has previously taken place, the burial may be allowed of any person for whom, or any member of the family for which that grave space has been reserved and appropriated, with the exclusive right of burial there, but no part of the coffin containing the body shall be less than one metre below the level of the surface of the ground adjoining the grave.


Her Majesty in Council is pleased to give Notice of these representations and to order that they be taken into consideration by a Committee of the Privy Council on 19th November 2015.

### St Margaret's Churchyard Bentham





St Peter and St Paul's Churchyard, Uplyme, Devon





### St Mary's Churchyard, Peldon Road, Great Parndon Harlow






### Christ Church Cemetery, Linthwaite Huddersfield



### Churchyard Of St Mary The Virgin, Ideford






### St John The Evangelist Great Stanmore






### St John`s Churchyard Newton-on-Rawcliffe Pickering




St Peter & St Paul Churchyard, Pickering


Representations were duly made to Her Majesty in Council by the Secretary of State for Justice that burials should be discontinued forthwith and entirely in:-
