*SCHEDULE*

AMENDMENTS TO THE STATUTES OF THE UNIVERSITY OF KEELE

1. In Statute 1 *delete* definition "Suspension" and *substitute*:  
  
    "\"Suspension\" means that a Student who has been suspended under the provisions of Regulation 21 may not, for the period of suspension, attend any examination, lecture, tutorial, seminar, class or other course, nor receive any formal academic instruction except as specified by the Deputy Vice-Chancellor. In all other respects the student shall remain subject to the Charter, Statutes, Ordinances and Regulations of the University.\"".
2. In Statute 8 paragraph 3:
  - (a) *delete* "his/her" and *substitute* "their";
  - (b) *delete* "him/her" and *substitute* "the Deputy Vice-Chancellor and Provost\"".
3. In Statute 12, 18 and 19 *delete* "Planning & Academic Administration" and *substitute* "Student & Academic Services" wherever it occurs.
4. In Statute 18 paragraph (g) *delete* "inclusive of the members stated in (j) below\"".
5. In Statute 28 paragraph 4 after "Audit" *insert* "& Risk" wherever it occurs.

6. In Statute 31:

- (a) in paragraph 2 *delete* "his" and *substitute* "their";
- (b) *delete* "him/her" and *substitute* "them" wherever it occurs;
- (c) *delete* paragraph 3.3;
- (d) *delete* "his/her" and *substitute* "their" wherever it occurs;
- (e) in paragraph 9.1 *delete* "he/her" and *substitute* "they are";
- (f) *delete* "Registrar" and *substitute* "Director of Human Resources" wherever it occurs;
- (g) in paragraphs 14.3, 14.4, 15.1 and 33.4 *delete* "he/she" and *substitute* "the Vice-Chancellor";
- (h) in paragraphs 14.5, 33.3 and 37.1(iii) *delete* "he/she" and *substitute* "they";
- (i) in paragraph 14.6 *delete* "himself/herself" and *substitute* "themselves";
- (j) in paragraph 15.2 and 27.3 *delete* "he/she" and *substitute* "the Director of Human Resources";
- (k) in paragraph 17.2(b) *delete* "by him/her";
- (l) in paragraph 27.2 *delete* "he/she has" and *substitute* "they have";
- (m) in paragraph 28.3 *delete* "considers" and *substitute* "consider";
- (n) in paragraph 33.4 *delete* "He/she" and *substitute* "The Vice-Chancellor";
- (o) *delete* paragraph 33.5 and *substitute*:  

"33.5. If the Vice-Chancellor does not reject the complaint under sub-clause (3) or if they do not defer action upon it under sub-clause (4) they shall decide whether it would be appropriate, having regard to the interests of justice and fairness, for them to seek to dispose of it informally. If the Vice-Chancellor so decides they shall notify the member and proceed accordingly.";
- (p) in paragraph 37.1(ii) *delete* "he/she" and *substitute* "the Chair of the Council".
