Whereas under section 3(1)(a), (b), (c), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our

Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain:

And Whereas under section 3(1)(f) and (ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that coins made at Our Mint other than gold, silver, cupro-nickel and bronze coins shall be current and that any coin shall be legal tender for the payment of any amount:

And Whereas under section 6(2) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to prescribe the composition of the standard trial plates to be used for determining the justness of coins of any metal other than gold, silver or cupro-nickel:

And Whereas it appears to Us desirable to order that, to celebrate the seventieth birthday of His Royal Highness The Prince of Wales, there should be made at Our Mint a new series of coins of the denomination of five pounds in gold, standard silver, silver piedfort, platinum piedfort and cupro-nickel; and a new series of coins of the denomination of twenty-five pounds in platinum.

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d), (dd), (f) and (ff), the said section 6(2), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

FIVE POUND GOLD COIN

1. (1) A new coin of gold of the denomination of five pounds shall be made, being a coin of a standard diameter of 38.61 millimetres, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 POUNDS \cdot 2018", and for the reverse a depiction of His Royal Highness The Prince of Wales with the inscription " \cdot H.R.H. THE PRINCE OF WALES \cdot " and "70TH BIRTHDAY". The coin shall have a plain edge.'

FIVE POUND STANDARD SILVER COIN

2. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 28.28 grammes, a standard diameter of 38.61 millimetres, a standard composition of 925 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.45 grammes;

(b) a variation from the said standard composition of five parts per thousand fine silver; and

(c) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 POUNDS \cdot 2018", and for the reverse a depiction of His Royal Highness The Prince of Wales with the inscription " \cdot H.R.H. THE PRINCE OF WALES \cdot " and "70TH BIRTHDAY". The coin shall have a plain edge.'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

FIVE POUND SILVER PIEDFORT COIN

3. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 56.56 grammes, a standard diameter of 38.61 millimetres, a standard composition of 925 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.215 grammes;

(b) a variation from the said standard composition of five parts per thousand fine silver; and

(c) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 POUNDS \cdot 2018", and for the reverse a depiction of His Royal Highness The Prince of Wales with the inscription " \cdot H.R.H. THE PRINCE OF WALES \cdot " and "70TH BIRTHDAY". The coin shall have a plain edge.'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

TWENTY-FIVE POUND PLATINUM COIN

4. (1) A new coin of platinum of the denomination of twenty-five pounds shall be made, being a coin of a standard weight of 7.846 grammes, a standard diameter of 20 millimetres and being circular in shape.

(2) In the making of the said platinum coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.075 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The said platinum coin may contain impurities of five-tenths of one per centum.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The composition of the standard trial plates to be used for determining the justness of the said platinum coin shall be pure platinum.

(6) The design of the said platinum coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 2018 \cdot 25 POUNDS", and for the reverse a depiction of His Royal Highness The Prince of Wales with the inscription " \cdot H.R.H. THE PRINCE OF WALES \cdot " and "70TH BIRTHDAY". The coin shall have a grained edge.'

(7) The said platinum coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

FIVE POUND PLATINUM PIEDFORT COIN

5. (1) A new coin of platinum of the denomination of five pounds shall be made, being a coin of a standard weight of 94.2 grammes, a standard diameter of 38.61 millimetres, and being circular in shape.

(2) In the making of the said platinum coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.85 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The said platinum coin may contain impurities of three-tenths of one per centum.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of coin.

(5) The composition of the standard trial plates to be used for determining the justness of the said platinum coin shall be pure platinum.

(6) The design of the said platinum coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 POUNDS \cdot 2018", and for the reverse a depiction of His Royal Highness The Prince of Wales with the inscription " \cdot H.R.H. THE PRINCE OF WALES \cdot " and "70TH BIRTHDAY". The coin shall have a plain edge.'

(7) The said platinum coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

FIVE POUND CUPRO-NICKEL COIN

6. (1) A new coin of cupro-nickel of the denomination of five pounds shall be made, being a coin of a standard weight of 28.28 grammes, a standard diameter of 38.61 millimetres, a standard composition of seventy-five per centum copper and twenty-five per centum nickel, and being circular in shape.

(2) In the making of the said cupro-nickel coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.75 grammes;

(b) a variation from the said standard composition of two per centum copper and two per centum nickel; and

(c) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The said cupro-nickel coin may contain impurities of three-quarters of one per centum.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The design of the said cupro-nickel coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 POUNDS \cdot 2018", and for the reverse a depiction of His Royal Highness the Prince of Wales with the inscription " \cdot H.R.H. THE PRINCE OF WALES " and "70TH BIRTHDAY". The coin shall have a grained edge.'

(6) The said cupro-nickel coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

7. This Proclamation shall come into force on the fifteenth day of March Two thousand and eighteen.

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d), (dd), (f) and (ff), the said section 6(2), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

FIVE HUNDRED POUND GOLD COIN

1. (1) A new gold coin of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 50 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.8 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The least current weight of the said gold coin shall be 154.5 grammes.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 500 POUNDS", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 50Z FINE GOLD 999.9 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 50Z FINE GOLD 999.9 2019".

The coin shall have a grained edge.'

ONE HUNDRED POUND GOLD COIN

2. (1) A new coin of gold of the denomination of one hundred pounds shall be made, being a coin of a standard weight of 31.21 grammes, a standard diameter of 32.69 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.15 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The least current weight of the said gold coin shall be 31.01 grammes.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 100 POUNDS", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 10Z FINE GOLD 999.9 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 10Z FINE GOLD 999.9 2019".

The coin shall have a grained edge.'

FIFTY POUND GOLD COIN

3. (1) A new coin of gold of the denomination of fifty pounds shall be made, being a coin of a standard weight of 15.6 grammes, a standard diameter of 27 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.045 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The least current weight of the said gold coin shall be 15.505 grammes.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 50 POUNDS", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/2OZ FINE GOLD 999.9 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/2OZ FINE GOLD 999.9 2019".

The coin shall have a grained edge.'

TWENTY-FIVE POUND GOLD COIN

4. (1) A new coin of gold of the denomination of twenty-five pounds shall be made, being a coin of a standard weight of 7.8 grammes, a standard diameter of 22 millimetres, a millesimal fineness of not more than 999.9, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.025 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The least current weight of the said gold coin shall be 7.75 grammes.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 25 POUNDS", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/4OZ FINE GOLD 999.9 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/4OZ FINE GOLD 999.9 2019".

The coin shall have a grained edge.'

TEN POUND GOLD COIN

5. (1) A new coin of gold of the denomination of ten pounds shall be made, being a coin of a standard weight of 3.13 grammes, a standard diameter of 16.5 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.02 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The least current weight of the said gold coin shall be 3.11 grammes.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 10 POUNDS", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/100Z FINE GOLD 999.9 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/100Z FINE GOLD 999.9 2019".

The coin shall have a grained edge.'

ONE POUND GOLD COIN

6. (1) A new coin of gold of the denomination of one pound shall be made, being a coin of a standard weight of 1.58 grammes, a standard diameter of 12 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.02 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The least current weight of the said gold coin shall be 1.56 grammes.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 1 POUND", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/200Z FINE GOLD 999.9 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/200Z FINE GOLD 999.9 2019".

The coin shall have a grained edge.'

FIFTY PENCE GOLD COIN

7. (1) A new coin of gold of the denomination of fifty pence shall be made, being a coin of a standard weight of 0.8 grammes, a standard diameter of 8 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.015 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The least current weight of the said gold coin shall be 0.65 grammes.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 50 PENCE", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/40OZ FINE GOLD 999.9 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/400Z FINE GOLD 999.9 2019".

The coin shall have a grained edge.'

FIVE HUNDRED POUND SILVER COIN

8. (1) A new coin of silver of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 1005 grammes, a standard diameter of 100 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 5 grammes; and

(b) a variation from the said standard diameter of 0.25 millimetres per coin.

(3) The variation from the standard weight will be measured by weighing each coin separately.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 500 POUNDS", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1 KILO FINE SILVER 999 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1 KILO FINE SILVER 999 2019".

The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

TEN POUND SILVER COIN

9. (1) A new coin of silver of the denomination of ten pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 65 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.85 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 10 POUNDS", and for reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 5OZ FINE SILVER 999 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 50Z FINE SILVER 999 2019".

The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

TWO POUND SILVER COIN

10. (1) A new coin of silver of the denomination of two pounds shall be made, being a coin of a standard weight of 31.21 grammes, a standard diameter of 38.61 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.15 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 2 POUNDS", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 10Z FINE SILVER 999 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 10Z FINE SILVER 999 2019".

The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

ONE POUND SILVER COIN

11. (1) A new coin of silver of the denomination of one pound shall be made, being a coin of a standard weight of 15.71 grammes, a standard diameter of 27 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.16 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 1 POUND", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/2OZ FINE SILVER 999 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/2OZ FINE SILVER 999 2019".

The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

FIFTY PENCE SILVER COIN

12. (1) A new coin of silver of the denomination of fifty pence shall be made, being a coin of a standard weight of 7.86 grammes, a standard diameter of 22 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.08 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 50 PENCE", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/4OZ FINE SILVER 999 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/4OZ FINE SILVER 999 2019".

The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

TWENTY PENCE SILVER COIN

13. (1) A new coin of silver of the denomination of twenty pence shall be made, being a coin of a standard weight of 3.15 grammes, a standard diameter of 16.5 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.035 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 20 PENCE", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/10OZ FINE SILVER 999 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/100Z FINE SILVER 999 2019".

The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

TEN PENCE SILVER COIN

14. (1) A new coin of silver of the denomination of ten pence shall be made, being a coin of a standard weight of 1.58 grammes, a standard diameter of 12 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.025 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 10 PENCE", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/200Z FINE SILVER 999 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/200Z FINE SILVER 999 2019".

The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

FIVE PENCE SILVER COIN

15. (1) A new coin of silver of the denomination of five pence shall be made, being a coin of a standard weight of 0.8 grammes, a standard diameter of 8 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.015 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 PENCE", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/40OZ FINE SILVER 999 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/400Z FINE SILVER 999 2019".

The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

TWENTY-FIVE POUND PLATINUM COIN

16. (1) A new coin of platinum of the denomination of twenty-five pounds shall be made, being a coin of a standard weight of 7.846 grammes; a standard diameter of 20 millimetres and being circular in shape.

(2) In the making of the said platinum coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.075 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The said platinum coin may contain impurities of five-tenths of one per centum.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The composition of the standard trial plates to be used for determining the justness of the said platinum coin shall be pure platinum.

(6) The design of the said platinum coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 25 POUNDS", and for the reverse either:

(a) the figure of Britannia wearing a Corinthian helmet garlanded with the floral symbols of Britain and the inscription "BRITANNIA 1/4OZ PLATINUM 999.5 2018"; or

(b) the figure of Britannia holding a trident and shield and accompanied by a lion, and the inscription "BRITANNIA 1/40OZ PLATINUM 999.5 2019".

The coin shall have a grained edge.'

(7) The said platinum coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

17. This Proclamation shall come into force on the fifteenth day of March Two thousand and eighteen.

DETERMINING THE SPECIFICATIONS AND DESIGNS FOR A NEW SERIES OF FIVE POUND COINS IN GOLD AND SILVER COMMEMORATING THE HUNDREDTH ANNIVERSARY OF THE FIRST WORLD WAR

Whereas under section 3(1)(a), (b), (c), (cc), (cd), and (d) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy

money, and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins:

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that, to commemorate the hundredth anniversary of the First World War, there should be made at Our Mint a new series of coins of the denomination of five pounds in gold and in silver:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

FIVE POUND GOLD COIN

1. (1) A new coin of gold of the denomination of five pounds shall be made, being a coin of a standard diameter of 38.61 millimetres, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard diameter specified above) shall be allowed of an amount not exceeding 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

FIVE POUND SILVER COIN

2. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 28.28 grammes, a standard diameter of 38.61 millimetres, a standard composition of 925 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.45 grammes;

(b) a variation from the said standard composition of five parts per thousand fine silver; and

(c) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

DESIGN OF THE COINS

3. (1) The design of the said five pound gold and silver coins shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 POUNDS \cdot 2018", and for the reverse either:

(a) a portrait of T.E. Lawrence, accompanied by an image of soldiers on camels with the inscription "1914 THE FIRST WORLD WAR 1918" and "T.E. LAWRENCE" around the coin; separated by poppy flowers attached with barbed wire. The said coin shall have a plain edge and in incuse letters the inscription "I WROTE MY WILL ACROSS THE SKY IN STARS"; or

(b) a depiction of the aftermath of the Battle of Ypres, showing British soldiers by a grave and the inscription " \cdot 1914 THE FIRST WORLD WAR 1918 \cdot YPRES". The said coin shall have a plain edge and in incuse letters the inscription "HERE WAS THE WORLD'S WORST WOUND"; or

(c) a view of a First World War tank and the inscription "1914 THE FIRST WORLD WAR 1918". The said coin shall have a plain edge and in incuse letters the inscription "THE DEVIL IS COMING"; or

(d) a view of a woman working in a factory and the inscription "1914 THE FIRST WORLD WAR 1918". The said coin shall have a plain edge and in incuse letters the inscription "ON HER THEIR LIVES DEPEND"; or

(e) a depiction of a bi-plane from the First World War and the inscription " \cdot 1914 THE FIRST WORLD WAR 1918 \cdot ROYAL AIR FORCE". The said coin shall have a plain edge and in incuse letters the inscription "TUMULT IN THE CLOUDS"; or

(f) a design showing a Victory Medal on a letter in front of a family portrait and the inscription "1914 THE FIRST WORLD WAR 1918". The said coin shall have a plain edge and in incuse letters the inscription "THE WATCHERS BY LONELY HEARTHS".'

4. This Proclamation shall come into force on the fifteenth day of March Two thousand and eighteen.

Whereas under section 3(1)(a), (b), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain: And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denomination of five pounds in standard silver, silver piedfort and cupro-nickel:

We, therefore, in pursuance of the said section 3(1)(a), (b), (cc), (cd), (d), (dd) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

FIVE POUND STANDARD SILVER COIN

1. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 28.28 grammes, a standard diameter of 38.61 millimetres, a standard composition of 925 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.45 grammes;

(b) a variation from the said standard composition of five parts per thousand fine silver; and

(c) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 POUNDS \cdot 2018", and for the reverse a depiction of a poppy with the inscription "REMEMBRANCE". The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

FIVE POUND SILVER PIEDFORT COIN

2. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 56.56 grammes, a standard diameter of 38.61

millimetres, a standard composition of 925 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.215 grammes;

(b) a variation from the said standard composition of five parts per thousand fine silver; and

(c) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 POUNDS \cdot 2018", and for the reverse a depiction of a poppy with the inscription "REMEMBRANCE". The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

FIVE POUND CUPRO-NICKEL COIN

3. (1) A new coin of cupro-nickel of the denomination of five pounds shall be made, being a coin of a standard weight of 28.28 grammes, a standard diameter of 38.61 millimetres, a standard composition of seventy-five per centum copper and twenty-five per centum nickel, and being circular in shape.

(2) In the making of the said cupro-nickel coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.75 grammes;

(b) a variation from the said standard composition of two per centum copper and two per centum nickel; and

(c) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The said cupro-nickel coin may contain impurities of three-quarters of one per centum.

(5) The design of the said cupro-nickel coin shall be either:

(a) 'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 5 POUNDS \cdot 2018", and for the reverse a depiction of a poppy with the inscription "REMEMBRANCE"; or

(b) For the obverse impression Our effigy with the inscription "· ELIZABETH II \cdot D \cdot G \cdot REG \cdot FID \cdot DEF \cdot 5 POUNDS", and for the reverse a depiction of four ballerinas and four carved nutcrackers in the shape of soldiers surrounded by the inscription "CHRISTMAS 2018 THE NUTCRACKER" and decorative ribbons.

The coin shall have a grained edge.'

(6) The said cupro-nickel coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

4. This Proclamation shall come into force on the fifteenth day of March Two thousand and eighteen.

Whereas under section 3(1)(a), (b), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain: And Whereas under section 3(1)(f) and (ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that coins made at Our Mint other than gold, silver, cupro-nickel and bronze coins shall be current and that any coin shall be legal tender for the payment of any amount:

And Whereas under section 6(2) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to prescribe the composition of the standard trial plates to be used for determining the justness of coins of any metal other than gold, silver or cupro-nickel:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denomination of one pound in platinum.

We, therefore, in pursuance of the said section 3(1)(a), (b), (cc), (cd), (d), (dd), (f) and (ff), the said section 6(2), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

ONE POUND PLATINUM COIN

1. (1) A new coin of platinum of the denomination of one pound shall be made, being a coin of a standard weight of 21.56 grammes, a standard diameter of 23.03 millimetres and having joined concentric inner and outer sections, the outer section being plated with fine gold.

(2) In the making of the said platinum coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.35 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The said platinum coin may contain impurities of five-tenths of one per centum.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(5) The composition of the standard trial plates to be used for determining the justness of the said platinum coin shall be pure platinum.

(6) The design of the said platinum coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D £1", and the date of the year and for the reverse a depiction of a rose, leek, thistle and shamrock encircled by and emerging from a crown with the

inscription "ONE POUND" below. The coin shall have alternate grained and plain edges.'

(7) The said platinum coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

2. This Proclamation shall come into force on the fifteenth day of March Two thousand and eighteen.

- 4) St Kenelm's Churchyard, Sapperton, Cirencester, Gloucestershire (as shown hatched on the plan annexed hereto).


The exceptions are that:-


- (a) in the places numbered 1, 2 and 3 above, in any vault or walled grave in the churchyard, burial may be allowed but every coffin in such vault or grave must be separately enclosed by stonework or brick work properly cemented;
- (b) in the places numbered 1, 2 and 3 above, in any existing earthen grave in the churchyard, the burial may be allowed of the body of any member of the family of the person or persons previously buried in that grave, but no part of the coffin containing the body shall be less than one metre below the level of the surface of the ground adjoining the grave; and

(c) in the places numbered 2 and 3 above, in any grave space in which no interment has previously taken place, the burial may be allowed of any person for whom, or any member of the family for which that grave space has been reserved and appropriated, with the exclusive right of burial there, but no part of the coffin containing the body shall be less than one metre below the level of the surface of the ground adjoining the grave.





St Andrew's Church, Rippingale, Lincolnshire Siteplan (drwg no. 430.75 / 02) 15 March 2017


