DETERMINING THE SPECIFICATIONS AND DESIGNS FOR A NEW SERIES OF TWO THOUSAND POUND, ONE THOUSAND POUND, FIVE HUNDRED POUND, TWO HUNDRED POUND, ONE HUNDRED POUND AND TWENTY-FIVE POUND GOLD COINS; A NEW SERIES OF FIVE HUNDRED POUND GOLD PIEDFORT COINS; A NEW SERIES OF ONE THOUSAND POUND, FIVE HUNDRED POUND, TEN POUND, FIVE POUND AND TWO POUND STANDARD SILVER COINS; A NEW SERIES OF TEN POUND SILVER PIEDFORT COINS; A NEW SERIES OF TEN POUND AND FIVE POUND SILVER BULLION COINS; A NEW SERIES OF ONE HUNDRED POUND PLATINUM COINS; AND A NEW SERIES OF FIVE POUND CUPRO-NICKEL COINS

Whereas under section 3(1)(a), (b), (c), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain:

And Whereas under section 3(1)(f) and (ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that coins made at Our Mint other than gold, silver, cupro-nickel and bronze coins shall be current and that any coin shall be legal tender for the payment of any amount:

And Whereas under section 6(2) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to prescribe the composition of the standard trial plates to be used for determining the justness of coins of any metal other than gold, silver or cupro-nickel:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denominations of two thousand pounds, one thousand pounds, five hundred pounds, two hundred pounds, one hundred pounds and twenty-five pounds in gold, a new series of coins of the denomination of five hundred pounds in gold piedfort, a new series of coins of the denominations of one thousand pounds, five hundred pounds, ten pounds, five pounds and two pounds in standard silver, a new series of coins of the denomination of ten pounds in silver piedfort, a new series of coins in the denomination of ten pounds and five pounds in silver bullion, a new series of coins of the denomination of one hundred pounds platinum, and a new series of coins of the denomination of five pounds in cupro-nickel:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d), (dd), (f) and (ff), the said section 6(2), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

TWO THOUSAND POUND GOLD COIN

- 1. (1) A new coin of gold of the denomination of two thousand pounds shall be made, being a coin of a standard weight of 2010 grammes, a standard diameter of 150 millimetres, a millesimal fineness of not less than 999, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 11.97 grammes; and
 - (b) a variation from the said standard diameter of 0.6 millimetres per coin.
 - (3) The least current weight of the said gold coin shall be 1995.04 grammes.
- (4) The variation from the standard weight will be measured by weighing each coin separately.
 - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· ELIZABETH II · D · G · REG · F · D · 2000 POUNDS", and for the reverse a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT" and the date of the year. The coin shall have a grained edge.'

ONE THOUSAND POUND GOLD COIN

- 2. (1) A new coin of gold of the denomination of one thousand pounds shall be made, being a coin of a standard weight of 1005 grammes, a standard diameter of 100 millimetres, a millesimal fineness of not less than 999, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
 - (a) a variation from the said standard weight of an amount per coin of 6 grammes; and
 - (b) a variation from the said standard diameter of 0.3 millimetres per coin.
 - (3) The least current weight of the said gold coin shall be 997.50 grammes.
- (4) The variation from the standard weight will be measured by weighing each coin separately.
 - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 1000 POUNDS", and for the reverse a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT" and the date of the year. The coin shall have a grained edge.'

FIVE HUNDRED POUND GOLD COIN

- 3. (1) A new coin of gold of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 156.3 grammes, a standard diameter of 50 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.937 grammes; and
 - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
 - (3) The least current weight of the said gold coin shall be 155.12 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
 - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· ELIZABETH II · D · G · REG · F · D · 500 POUNDS", and for the reverse a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT" and the date of the year. The coin shall have a grained edge.'

TWO HUNDRED POUND GOLD COIN

- 4. (1) A new coin of gold of the denomination of two hundred pounds shall be made, being a coin of a standard weight of 62.42 grammes, a standard diameter of 40 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight, diameter or fineness specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.240 grammes; and
 - (b) a variation from the said standard diameter of 0.125 millimetres per coin;
 - (3) The least current weight of the said gold coin shall be 62.12 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
 - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· ELIZABETH II · D · G · REG · F · D · 200 POUNDS", and for the reverse a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT" and the date of the year. The coin shall have a grained edge.'

ONE HUNDRED POUND GOLD COIN

- 5. (1) A new coin of gold of the denomination of one hundred pounds shall be made, being a coin of a standard weight of 31.21 grammes, a standard diameter of 32.69 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.12 grammes; and
 - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
 - (3) The least current weight of the said gold coin shall be 31.06 grammes.

- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
 - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 100 POUNDS", and for the reverse either:

- (a) a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT" and the date of the year; or
- (b) a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT · 10Z · FINE GOLD · 999.9" and the date of the year.

The coin shall have a grained edge.'

TWENTY-FIVE POUND GOLD COIN

- 6. (1) A new coin of gold of the denomination of twenty-five pounds shall be made, being a coin of a standard weight of 7.8 grammes, a standard diameter of 22 millimetres, a millesimal fineness of not more than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.024 grammes; and
 - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
 - (3) The least current weight of the said gold coin shall be 7.77 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
 - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 25 POUNDS", and for the reverse either:

- (a) a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT" and the date of the year;

FIVE HUNDRED POUND GOLD PIEDFORT COIN

- 7. (1) A new coin of gold of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 312.52 grammes, a standard diameter of 65 millimetres, a millesimal fineness of not less than 999, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 1.392 grammes; and
 - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
 - (3) The least current weight of the said gold coin shall be 310.78 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
 - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " \cdot ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 500 POUNDS", and for the reverse a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT" and the date of the year. The coin shall have a grained edge.'

ONE THOUSAND POUND STANDARD SILVER COIN

- 8. (1) A new coin of silver of the denomination of one thousand pounds shall be made, being a coin of a standard weight of 2010 grammes, a standard diameter of 150 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 11.97 grammes; and
 - (b) a variation from the said standard diameter of 0.6 millimetres per coin.
- (3) The variation from the standard weight will be measured by weighing each coin separately.
 - (4) The design of the said silver coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "· ELIZABETH II · D · G · REG · F · D · 1000 POUNDS", and for the reverse a depiction of the Yale of Beaufort

accompanied by the inscription "YALE OF BEAUFORT" and the date of the year. The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

FIVE HUNDRED POUND STANDARD SILVER COIN

- 9. (1) A new coin of silver of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 1005 grammes, a standard diameter of 100 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
 - (a) a variation from the said standard weight of an amount per coin of 6 grammes; and
 - (b) a variation from the said standard diameter of 0.3 millimetres per coin.
- (3) The variation from the standard weight will be measured by weighing each coin separately.
 - (4) The design of the said silver coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "· ELIZABETH II · D · G · REG · F · D · 500 POUNDS" and for the reverse a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT" and the date of the year. The coin shall have a grained edge.'
- (5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

TEN POUND STANDARD SILVER COIN

- 10. (1) A new coin of silver of the denomination of ten pounds shall be made, being a coin of a standard weight of 156.3 grammes, a standard diameter of 65 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.934 grammes; and
 - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· ELIZABETH II · D · G · REG · F · D · 10 POUNDS", and for the reverse a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT" and the date of the year. The coin shall have a grained edge.'

FIVE POUND STANDARD SILVER COIN

- 11. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 62.42 grammes, a standard diameter of 40 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 1.1 grammes; and
 - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
 - (4) The design of the said silver coin shall be as follows:

- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.12 grammes; and

- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
 - (4) The design of the said silver coin shall be as follows:

- (a) a variation from the said standard weight of an amount per coin of 1.80 grammes; and
 - (b) a variation from the said standard diameter of 0.125 millimetres per coin.

- (a) a variation from the said standard weight of an amount per coin of 0.566 grammes; and
 - (b) a variation from the said standard diameter of 0.3 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
 - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· ELIZABETH II · D · G · REG · F · D · 10 POUNDS", and for the reverse a depiction of the Yale of Beaufort accompanied by the inscription "YALE OF BEAUFORT · 10OZ · FINE SILVER · 999.9 ·" and the date of the year. - (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.228 grammes; and
 - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
 - (4) The design of the said silver coin shall be as follows:



Her Majesty in Council is pleased to give Notice of these representations and to order that they be taken into consideration by a Committee of the Privy Council on 27th April 2022.

And Her Majesty is further pleased to direct that this Order should be published in the London Gazette, and that copies of it should be fixed on the doors of the Churches or Chapels of the above mentioned places, or displayed conspicuously inside them, for one month before 27th April 2022.


Representations were duly made to Her Majesty in Council by the Secretary of State for Justice that, subject to the exceptions below, burials should be discontinued forthwith in St John the Evangelist Churchyard, Sewerby, East Yorkshire (as shown hatched on the plan annexed hereto).

In pursuance of the Order in Council made on 15th December 2021 these representations have been published and taken into consideration by a Committee of the Privy Council.

Accordingly, Her Majesty, in exercise of the powers conferred on Her by section 1 of the Burial Act 1853, is pleased, by and with the advice of Her Privy Council, to order that burials shall be discontinued forthwith in the place listed above, subject to the following exceptions:-

- (a) in any vault or walled grave in the churchyard, burial may be allowed but every coffin in such vault or grave must be separately enclosed by stonework or brick work properly cemented;
- (b) in any existing earthen grave in the churchyard, the burial may be allowed of the body of any member of the family of the person or persons previously buried in that grave, but no part of the coffin containing the body shall be less than one metre below the level of the surface of the ground adjoining the grave; and
- (c) in any grave space in which no interment has previously taken place, the burial may be allowed of any person for whom, or any member of the family for which that grave space has been reserved and appropriated, with the exclusive right of burial there, but no part of the coffin containing the body shall be less than one metre below the level of the surface of the ground adjoining the grave.
