SCHEDULE	-

AMENDMENTS TO THE BYE-LAWS OF THE ROYAL INSTITUTE OF INTERNATIONAL AFFAIRS

- 1. **Delete** Bye-law 4 and **substitute**:
  - "4. All Members shall register with the Institute a physical or electronic address to which communications and notices are to be sent and shall notify the Institute of any change to their address.".
- 2. **Delete** Bye-law 6 and **substitute**:
  - "6. The application shall be forwarded to the Secretary or any other person designated by them and a list of candidates applying for Membership shall be exhibited in a conspicuous place either at the Headquarters of the Institute or on the website of the Institute or in such other manner as Council deems appropriate, including by electronic means, for one week.".
- 3. **Delete** "Chairman" wherever it occurs and **substitute** "Chair".
- 4. In Bye-law 19:
  - (a) *delete* "The voting list shall be printed and where the number of candidates nominated does not exceed the number of vacancies it shall be posted on the Notice Board in the entrance hall of the premises of the Institute," and *substitute* "Where the number of candidates nominated does not exceed the number of vacancies it shall be exhibited at the

Headquarters of the Institute, on the website of the Institute or in such other manner as Council deems appropriate, including by electronic means,";

- (b) after "no name may be added to such list after the same has been" *delete* "printed and" and *substitute* "exhibited or";
- (c) after "circulated" *insert* ", as the case may be".
- 5. In Bye-law 22:
  - (a) after "Twenty Members of the Institute present in person" *insert* "or by such other means as the Council shall from time to time decide is suitable for the proceedings to take place such that each participant is able to communicate with all the other participants,";
  - (b) after "when fifty Members must be present" *delete* "in person".
- 6. In Bye-law 24 after "show of hands" *insert* "or such other method of voting as the Council may determine".
- 7. In Bye-law 47:
  - (a) after "if it shall" delete "be";
  - (b) *delete* "Committees" and *substitute* "committees".
- 8. In Bye-law 51(c) *delete* "Executive Committee or any other Committees" and *substitute* "committees".
- 9. In Bye-law 57:
  - (a) after "Annual" *insert* "and any Extraordinary";
  - (b) *delete* "Committees" and *substitute* "committee meetings".
- 10. In Bye-law 68 after "Headquarters of the Institute" *insert* "or on the website of the Institute or in such other manner as Council deems appropriate, including by electronic means,".
