# **A PROCLAMATION**

DETERMINING THE SPECIFICATIONS AND DESIGN FOR A NEW SERIES OF FIVE THOUSAND POUND, TWO THOUSAND POUND, ONE THOUSAND POUND, FIVE HUNDRED POUND AND TWO HUNDRED POUND GOLD COINS; A NEW SERIES OF FIVE HUNDRED POUND, TEN POUND AND FIVE POUND STANDARD SILVER COINS; AND A NEW SERIES OF TEN POUND SILVER PIEDFORT COINS

# CHARLES R.

Whereas under section 3(1)(a), (b), (c), (cc), (cd) and (d) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, and to provide for the manner of measurement of the variation from the standard weight of coins:

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denominations of five thousand pounds, two thousand pounds, one thousand pounds, five hundred pounds, and two hundred pounds in gold, a new series of coins of the denominations of five hundred pounds, ten pounds and five pounds in standard silver, and a new series of coins of the denomination of ten pounds in silver piedfort:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d) and (ff) and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

#### FIVE THOUSAND POUND GOLD COIN

- 1. (1) A new coin of gold of the denomination of five thousand pounds shall be made, being a coin of a standard weight of 5015 grammes, a standard diameter of 175 millimetres, a millesimal fineness of not less than 999, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
  - (a) a variation from the said standard weight of an amount per coin of 40 grammes; and
  - (b) a variation from the said standard diameter of 2.085 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 4975 grammes.
- (4) The variation from the standard weight will be measured by weighing each coin separately.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  5000 POUNDS  $\cdot$ " and the date of the year, and for the reverse a depiction of St George, armed, sitting on horseback, attacking a dragon with a sword, and a broken spear upon the ground with the inscription "HONI  $\cdot$  SOIT  $\cdot$  QUI  $\cdot$  MAL  $\cdot$  Y  $\cdot$  PENSE". The coin shall have a plain edge and in excuse letters the inscription "DECUS ET TUTAMEN  $\cdot$  ANNO REGNI II  $\cdot$ ".'

#### TWO THOUSAND POUND GOLD COIN

2. (1) A new coin of gold of the denomination of two thousand pounds shall be made, being a coin of a standard weight of 2010 grammes, a standard diameter of 125 millimetres, a millesimal fineness of not less than 999, and being circular in shape.

- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
  - (a) a variation from the said standard weight of an amount per coin of 40 grammes; and
  - (b) a variation from the said standard diameter of 0.6 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 1970 grammes.
- (4) The variation from the standard weight will be measured by weighing each coin separately.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  2000 POUNDS  $\cdot$ " and the date of the year, and for the reverse a depiction of St George, armed, sitting on horseback, attacking a dragon with a sword, and a broken spear upon the ground with the inscription "HONI  $\cdot$  SOIT  $\cdot$  QUI  $\cdot$  MAL  $\cdot$  Y  $\cdot$  PENSE". The coin shall have a plain edge and in excuse letters the inscription "DECUS ET TUTAMEN  $\cdot$  ANNO REGNI II  $\cdot$ ".'

#### ONE THOUSAND POUND GOLD COIN

- 3. (1) A new coin of gold of the denomination of one thousand pounds shall be made, being a coin of a standard weight of 1005 grammes, a standard diameter of 100 millimetres, a millesimal fineness of not less than 999, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
  - (a) a variation from the said standard weight of an amount per coin of 30 grammes; and
  - (b) a variation from the said standard diameter of 0.6 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 975 grammes.
- (4) The variation from the standard weight will be measured by weighing each coin separately.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  1000 POUNDS  $\cdot$ " and the date of the year, and for the reverse a depiction of St George, armed, sitting on horseback, attacking a dragon with a sword, and a broken spear upon the ground with the inscription "HONI  $\cdot$  SOIT  $\cdot$  QUI  $\cdot$  MAL  $\cdot$  Y  $\cdot$  PENSE". The coin shall have a plain edge and in excuse letters the inscription "DECUS ET TUTAMEN  $\cdot$  ANNO REGNI II  $\cdot$ ".'

#### FIVE HUNDRED POUND GOLD COIN

- 4. (1) A new coin of gold of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 156.3 grammes, a standard diameter of 50.6 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.937 grammes; and
  - (b) a variation from the said standard diameter of 0.585 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 155.12 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 500 POUNDS ·" and the date of the year, and for the reverse a depiction of St George, armed, sitting on horseback, attacking a dragon with a sword, and a broken spear upon the ground with the inscription "HONI · SOIT · QUI · MAL · Y · PENSE". The coin shall have a plain edge and in excuse letters the inscription "DECUS ET TUTAMEN · ANNO REGNI II ·".'

# TWO HUNDRED POUND GOLD COIN

- 5. (1) A new coin of gold of the denomination of two hundred pounds shall be made, being a coin of a standard weight of 62.42 grammes, a standard diameter of 40.6 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.24 grammes; and
  - (b) a variation from the said standard diameter of 0.585 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 62.12 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 200 POUNDS ·" and the date of the year, and for the reverse a depiction of St George, armed, sitting on horseback, attacking a dragon with a sword, and a broken spear upon the ground with the inscription "HONI · SOIT · QUI · MAL · Y · PENSE". The coin shall have a plain edge and in excuse letters the inscription "DECUS ET TUTAMEN · ANNO REGNI II ·".'

#### FIVE HUNDRED POUND STANDARD SILVER COIN

- 6. (1) A new coin of silver of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 1005.01 grammes, a standard diameter of 100.6 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
  - (a) a variation from the said standard weight of an amount per coin of 30 grammes; and
  - (b) a variation from the said standard diameter of 0.6 millimetres per coin.
- (3) The variation from the standard weight will be measured by weighing each coin separately.
  - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 500 POUNDS ·" and the date of the year, and for the reverse a depiction of St George, armed, sitting on horseback, attacking a dragon with a sword, and a broken spear upon the ground with the inscription "HONI · SOIT · QUI · MAL · Y · PENSE". The coin shall have a plain edge and in excuse letters the inscription "DECUS ET TUTAMEN · ANNO REGNI II ·".'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

#### TEN POUND STANDARD SILVER COIN

- 7. (1) A new coin of silver of the denomination of ten pounds shall be made, being a coin of a standard weight of 156.3 grammes, a standard diameter of 65.6 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.934 grammes; and

- (b) a variation from the said standard diameter of 0.585 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 10 POUNDS ·" and the date of the year, and for the reverse a depiction of St George, armed, sitting on horseback, attacking a dragon with a sword, and a broken spear upon the ground with the inscription "HONI · SOIT · QUI · MAL · Y · PENSE". The coin shall have a plain edge and in excuse letters the inscription "DECUS ET TUTAMEN · ANNO REGNI II ·".'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

#### FIVE POUND STANDARD SILVER COIN

- 8. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 62.86 grammes, a standard diameter of 40.6 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.784 grammes; and
  - (b) a variation from the said standard diameter of 0.585 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 5 POUNDS ·" and the date of the year, and for the reverse a depiction of St George, armed, sitting on horseback, attacking a dragon with a sword, and a broken spear upon the ground with the inscription "HONI · SOIT · QUI · MAL · Y · PENSE". The coin shall have a plain edge and in excuse letters the inscription "DECUS ET TUTAMEN · ANNO REGNI II ·".'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

#### TEN POUND SILVER PIEDFORT COIN

- 9. (1) A new coin of silver of the denomination of ten pounds shall be made, being a coin of a standard weight of 312.59 grammes, a standard diameter of 65.6 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
  - (a) a variation from the said standard weight of an amount per coin of 1.8 grammes; and
  - (b) a variation from the said standard diameter of 0.585 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  10 POUNDS  $\cdot$ " and the date of the year, and for the reverse a depiction of St George, armed, sitting on horseback, attacking a dragon with a sword, and a broken spear upon the ground with the inscription "HONI  $\cdot$  SOIT  $\cdot$  QUI  $\cdot$  MAL  $\cdot$  Y  $\cdot$  PENSE". The coin shall have a plain edge and in excuse letters the inscription "DECUS ET TUTAMEN  $\cdot$  ANNO REGNI II  $\cdot$ ".'

- (5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.
- 10. This Proclamation shall come into force on the fourteenth day of December Two thousand and twenty-three.

Given at Our Court at Buckingham Palace, this thirteenth day of December in the year of Our Lord Two thousand and twenty-three and in the second year of Our Reign.

DETERMINING THE SPECIFICATIONS AND DESIGNS FOR A NEW SERIES OF ONE THOUSAND POUND, FIVE HUNDRED POUND, ONE HUNDRED POUND, FIFTY POUND, TWENTY-FIVE POUND, TEN POUND, ONE POUND AND FIFTY PENCE GOLD COINS; A NEW SERIES OF FIVE HUNDRED POUND, TEN POUND, FIVE POUND, TWO POUND, ONE POUND, FIFTY PENCE, TWENTY PENCE, TEN PENCE AND FIVE PENCE SILVER COINS; AND A NEW SERIES OF TWENTY-FIVE POUND PLATINUM COINS

#### CHARLES R.

Whereas under section 3(1)(a), (b), (c), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain:

And Whereas under section 3(1)(f) and (ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that coins made at Our Mint other than gold, silver, cupro-nickel and bronze coins shall be current and that any coin shall be legal tender for the payment of any amount:

And Whereas under section 6(2) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to prescribe the composition of the standard trial plates to be used for determining the justness of coins of any metal other than gold, silver or cupro-nickel:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denominations of one thousand pounds, five hundred pounds, one hundred pounds, fifty pounds, twenty-five pounds, ten pounds, one pound and fifty pence in gold, a new series of coins of the denominations of five hundred pounds, ten pounds, five pounds, two pounds, one pound, fifty pence, twenty pence, ten pence and five pence in silver, and a new series of coins of the denomination of twenty-five pounds in platinum:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d), (dd), (f) and (ff), the said section 6(2), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

#### ONE THOUSAND POUND GOLD COIN

- 1. (1) A new coin of gold of the denomination of one thousand pounds shall be made, being a coin of a standard weight of 1005 grammes, a standard diameter of 100 millimetres, a millesimal fineness of not less than 999, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
  - (a) a variation from the said standard weight of an amount per coin of 6 grammes; and
  - (b) a variation from the said standard diameter of 0.3 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 997.5 grammes.
- (4) The variation from the standard weight will be measured by weighing each coin separately.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 1000 POUNDS ·" and the date of the year, and for the reverse a depiction of the figures of Britannia and Liberty with the inscriptions "· BRITANNIA AND LIBERTY ·" and "· 1 KILO 999 FINE GOLD" accompanied by the date of the year. The coin shall have a grained edge.'

#### FIVE HUNDRED POUND GOLD COIN

- 2. (1) A new coin of gold of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 50 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.937 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 155.12 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  500 POUNDS  $\cdot$ " and the date of the year, and for the reverse a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 5OZ 999.9 FINE GOLD". The coin shall have a grained edge.'

#### ONE HUNDRED POUND GOLD COIN

- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.12 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 31.06 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 100 POUNDS ·" and the date of the year, and for the reverse either:

- (a) a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 1OZ 999.9 FINE GOLD"; or
- (b) a depiction of the figures of Britannia and Liberty with the inscriptions "BRITANNIA AND LIBERTY ·" and " $\cdot$  1OZ 999.9 FINE GOLD" accompanied by the date of the year.

The coin shall have a grained edge.'

#### FIFTY POUND GOLD COIN

- 4. (1) A new coin of gold of the denomination of fifty pounds shall be made, being a coin of a standard weight of 15.6 grammes, a standard diameter of 27 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.

- (a) a variation from the said standard weight of an amount per coin of 0.048 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 15.54 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  50 POUNDS  $\cdot$ " and the date of the year, and for the reverse a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 1/2OZ 999.9 FINE GOLD". # TWENTY-FIVE POUND GOLD COIN

- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.024 grammes; and

- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The least current weight of the said gold coin shall be 7.77 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  25 POUNDS  $\cdot$ " and the date of the year, and for the reverse either:

- (a) a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 1/4OZ 999.9 FINE GOLD"; or

- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  1 POUND  $\cdot$ " and the date of the year, and for the reverse a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 1/20OZ 999.9 FINE GOLD". The coin shall have a grained edge.

#### FIFTY PENCE GOLD COIN

- 8. (1) A new coin of gold of the denomination of fifty pence shall be made, being a coin of a standard weight of 0.8 grammes, a standard diameter of 8 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.012 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 0.79 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  50 PENCE  $\cdot$ " and the date of the year, and for the reverse either:

- (a) a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 1/40 OZ 999.9 FINE GOLD"; or
- (b) a depiction of the figures of Britannia and Liberty with the inscriptions "BRITANNIA AND LIBERTY ·" and "· 1/40 OZ 999.9 FINE GOLD" accompanied by the date of the year.

The coin shall have a grained edge.'

#### FIVE HUNDRED POUND SILVER COIN

- 9. (1) A new coin of silver of the denomination of five hundred pounds shall be made, being a coin of a standard weight of 1005 grammes, a standard diameter of 100 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
  - (a) a variation from the said standard weight of an amount per coin of 6 grammes; and
  - (b) a variation from the said standard diameter of 0.3 millimetres per coin.
- (3) The variation from the standard weight will be measured by weighing each coin separately.
  - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 500 POUNDS ·" and the date of the year, and for the reverse either:

- (a) a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year)1 KILO 999 FINE SILVER"; or
- (b) a depiction of the figures of Britannia and Liberty with the inscriptions "BRITANNIA AND LIBERTY ·" and " $\cdot$  1 KILO 999 FINE SILVER" accompanied by the date of the year.

The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

#### TEN POUND SILVER COIN

- 10. (1) A new coin of silver of the denomination of ten pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 65 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.934 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  10 POUNDS  $\cdot$ " and the date of the year, and for the reverse either:

- (a) a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 5OZ 999 FINE SILVER"; or
- (b) a depiction of the figures of Britannia and Liberty with the inscriptions "BRITANNIA AND LIBERTY ·" and "· 5OZ 999 FINE SILVER" accompanied by the date of the year.

The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

#### FIVE POUND SILVER COIN

- 11. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 62.86 grammes, a standard diameter of 40 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.784 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.

- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 5 POUNDS ·" and the date of the year, and for the reverse either:

- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.12 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  2 POUNDS  $\cdot$ " and the date of the year, and for the reverse either:

- (a) a variation from the said standard weight of an amount per coin of 0.092 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 50 PENCE ·" and the date of the year, and for the reverse a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 1/4OZ 999 FINE SILVER". The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

#### TWENTY PENCE SILVER COIN

- 15. (1) A new coin of silver of the denomination of twenty pence shall be made, being a coin of a standard weight of 3.15 grammes, a standard diameter of 16.5 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.036 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 20 PENCE ·" and the date of the year, and for the reverse a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 1/100Z 999 FINE SILVER". The coin shall have a grained edge.'
- (5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

#### TEN PENCE SILVER COIN

- 16. (1) A new coin of silver of the denomination of ten pence shall be made, being a coin of a standard weight of 1.58 grammes, a standard diameter of 12 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.024 grammes; and

- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 10 PENCE ·" and the date of the year, and for the reverse a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 1/200Z 999 FINE SILVER". The coin shall have a grained edge.'

(5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

#### FIVE PENCE SILVER COIN

- 17. (1) A new coin of silver of the denomination of five pence shall be made, being a coin of a standard weight of 0.8 grammes, a standard diameter of 8 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.012 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 5 PENCE ·" and the date of the year, and for the reverse a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 1/400Z 999 FINE SILVER". The coin shall have a grained edge.
- (5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

# TWENTY-FIVE POUND PLATINUM COIN

18. (1) A new coin of platinum of the denomination of twenty-five pounds shall be made, being a coin of a standard weight of 7.846 grammes, a standard diameter of 20 millimetres, a standard composition of not less than 999.5 parts per thousand platinum, and being circular in shape.

- (2) In the making of the said platinum coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.08 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The composition of the standard trial plate to be used for determining the justness of the said platinum coin shall be pure platinum.
  - (5) The design of the said platinum coin shall be as follows:

'For the obverse impression Our effigy with the inscription "· CHARLES III · D · G · REX · F · D · 25 POUNDS ·" and the date of the year, and for the reverse a depiction of the figure of Britannia and the inscription "BRITANNIA (the date of the year) 1/4OZ 999.5 PLATINUM". The coin shall have a grained edge.'

- (6) The said platinum coin shall be current and shall be legal tender for payment of any amount in any part of Our United Kingdom.
- 19. This Proclamation shall come into force on the fourteenth day of December Two thousand and twenty-three.

DETERMINING THE SPECIFICATIONS AND DESIGNS FOR A NEW SERIES OF TWO HUNDRED POUND, ONE HUNDRED POUND AND TWENTY-FIVE POUND GOLD COINS; A NEW SERIES OF TEN POUND, FIVE POUND AND TWO POUND SILVER COINS; AND A NEW SERIES OF FIVE POUND CUPRO-NICKEL COINS

# CHARLES R.

Whereas under section 3(1)(a), (b), (c), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain:

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denominations of two hundred pounds, one hundred pounds and twenty-five pounds in gold, a new series of coins of the denominations of ten pounds, five pounds and two pounds in silver, and a new series of coins of the denomination of five pounds in cupro-nickel:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d), (dd) and (ff) and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

#### TWO HUNDRED POUND GOLD COIN

- 1. (1) A new coin of gold of the denomination of two hundred pounds shall be made, being a coin of a standard weight of 62.42 grammes, a standard diameter of 40 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.24 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 62.12 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

'For the obverse impression Our effigy with the inscription " $\cdot$  CHARLES III  $\cdot$  D  $\cdot$  G  $\cdot$  REX  $\cdot$  F  $\cdot$  D  $\cdot$  200 POUNDS  $\cdot$ " and the date of the year, and for the reverse either:

- (a) a depiction of James Bond flying a light jet aircraft set against a background of James Bond titles and the inscription "007"; or
- (b) a depiction of the speedboat from the film The World is Not Enough set against a background of James Bond titles and the inscription "007".

The coin shall have a grained edge.'

#### ONE HUNDRED POUND GOLD COIN

- 2. (1) A new coin of gold of the denomination of one hundred pounds shall be made, being a coin of a standard weight of 31.21 grammes, a standard diameter of 32.69 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.12 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 31.06 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

- (a) a variation from the said standard weight of an amount per coin of 0.784 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

- (a) a variation from the said standard weight of an amount per coin of 0.12 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.

- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

#### FIVE POUND CUPRO-NICKEL COIN

(1) A new coin of cupro-nickel of the denomination of five pounds shall be made, being a coin of a standard weight of 28.28 grammes, a standard diameter of 38.61 millimetres, a standard composition of seventy-five per centum copper and twenty-five per centum nickel, and being circular in shape.
- (2) In the making of the said cupro-nickel coin a remedy (that is, a variation from the standard weight, diameter or composition specified above) shall be allowed of an amount not exceeding the following, that is to say:
  - (a) a variation from the said standard weight of an amount per coin of 0.852 grammes;
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin; and
- (c) a variation from the said standard composition of two per centum copper and two per centum nickel.
- (3) The said cupro-nickel coin may contain impurities of three-quarters of one per centum.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said cupro-nickel coin shall be as follows:

The coin shall have a grained edge.'

- (6) The said cupro-nickel coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denominations of two hundred pounds and one hundred pounds in gold, a new series of coins of the denominations of ten pounds, five pounds and two pounds in standard silver, and a new series of coins of the denomination of ten pounds in silver piedfort:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d) and (ff) and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

#### TWO HUNDRED POUND GOLD COIN

- 1. (1) A new coin of gold of the denomination of two hundred pounds shall be made, being a coin of a standard weight of 62.42 grammes, a standard diameter of 40 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.24 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 62.12 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

- (a) a variation from the said standard weight of an amount per coin of 0.12 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
  - (3) The least current weight of the said gold coin shall be 31.06 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (5) The design of the said gold coin shall be as follows:

#### TEN POUND STANDARD SILVER COIN

- 3. (1) A new coin of silver of the denomination of ten pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 65 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.934 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

#### FIVE POUND STANDARD SILVER COIN

4. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 62.86 grammes, a standard diameter of 40 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.784 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
  - (4) The design of the said silver coin shall be as follows:

'For the obverse impression Our Effigy with the inscription "· CHARLES III · D · G · REX · F · D · 5 POUNDS ·" and the date of the year, and for the reverse an effigy of George V with the inscription "GEORGIVS V DEI GRA : BRITT : OMN : REX FID : DEF : IND : IMP :". The coin shall have a grained edge.'

#### TWO POUND STANDARD SILVER COIN

- 5. (1) A new coin of silver of the denomination of two pounds shall be made, being a coin of a standard weight of 31.21 grammes, a standard diameter of 38.61 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.12 grammes; and
  - (b) a variation from the said standard diameter of 0.125 millimetres per coin.

Amendments to the Charter of The Imperial College of Science, Technology and Medicine

- 1. **Delete** Article 5 sub-paragraphs (g) to (k) and **substitute**:
  - "(g) to borrow and raise money in any lawful manner as determined by the Council in accordance with the Statutes and any Ordinances or Regulations made thereunder and in doing so may give security for loans and enter into any instrument which is ancillary or incidental to the exercise of such powers;
  - (h) to give guarantees;
  - (i) to join or collaborate with any other institution, organisation, company, partnership, joint venture or association;
  - (j) to provide indemnity insurance to cover the liability of the members of the Council in accordance with the statutory provisions to purchase indemnity insurance;
  - (k) to enter into engagements and to accept obligations and liabilities in all respects without any restriction whatsoever; and
  - (l) generally to do all other lawful acts whatsoever that may be necessary for and conducive or incidental to the attainment of the objects of the University.".

- 2. In Article 8 *delete* "whether on the grounds of religion, race, ethnic origin, gender, sexual orientation, marital status (including civil partnerships), disability, age, social background, political belief or otherwise".
- 3. In Article 10:
  - (i) after "the constitution of the Council" *insert* "shall be as prescribed by or under the Statutes with";
  - (ii) *delete* "or" and *substitute* "of";
  - (iii) delete "Statutes" and substitute "Ordinances".
- 4. In Article 14 *delete* "or under the Statutes" and *substitute* "Ordinance".
- 5. **Delete** Articles 15 to 17 and **substitute**:
  - "15. There shall be a President of the University (hereinafter referred to as "the President"):
    - (a) who shall be appointed by the Council;
    - (b) who shall be the chief academic and administrative officer of the University; and
    - (c) whose powers and duties shall, subject to the provisions of this Our Charter, be as prescribed in or under the Statutes.
  - 16. There shall be such other officers of the University as may be designated in accordance with or under the Statutes.
  - 17. There shall be a Students' Union of the University (hereinafter referred to as "the Imperial College Union") for the benefit of the students of the University and in their interests as students which shall conduct its affairs in accordance with a constitution approved by the Council.".
- 6 **Delete** Article 19
- 7. **Renumber** Articles 20 to 27 as 19 to 26.
- 8. In Article 22 as renumbered *delete* "if approved by the Court".
- 9. **Delete** Article 23 as renumbered and **substitute**:
  - "23. For the purpose of this Our Charter, a "Special Resolution" means:
  - (a) a resolution passed at a meeting, of which at least 21 days' notice has been given, of not less than two-thirds of the members of the Council by a majority of not less than three-quarters of those present and voting at the meeting; and

- (b) a resolution passed in writing (without notice) by a majority of not less than three-quarters of the members of Council in accordance with the provisions of the Statutes.".
- 10. In Article 24 as renumbered *delete* "his and her" and *substitute* "their".

#### UNIVERSITY OF OXFORD

#### STATUTE APPROVED BY CONGREGATION ON

TUESDAY, 9 March 2021

WHEREAS it is expedient to change the existing provisions governing the Rhodes Professor of Race Relations, NOW the University of Oxford, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of His Majesty in Council, AS FOLLOWS.


In the Schedule to the Statutes, after part 70 insert the following new Part 71 (which moves and amends the existing provisions in Council Regulations 24 of 2002 concerning the Rhodes Professor of Race Relations; new text underlined, deleted text struck through):

#### 'Part 71: Professorship of African Studies Rhodes Professor of Race Relations

- 1. The University hereby accepts with deep gratitude the offer of the Rhodesian Selection Trust Group of Copper Mining Companies to provide for the permanent endowment of a Professorship of African Studies (the "Professorship" and the holder of the Professorship is the "Professor")Rhodes Professorship of Race Relations.
- 2. The Rhodes-Professor-of Race Relations shall research, lecture and give instruction in African Studies interracial relations.
- 3. The <u>P</u>professor shall be elected by an electoral board consisting of:
- (1) the Vice-Chancellor, or, if the head of the college specified in (2) of this clause is Vice-Chancellor, a person appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;
- (2) the head of the college to which the  $\underline{P}_{\overline{P}}$  rofessorship shall be for the time being allocated by Council under any regulation in that behalf, or, if the head is unable or unwilling to act, a person appointed by the governing body of the college on the occurrence of a vacancy to act as an elector on that occasion;
- (3) a person appointed by the governing body of the college specified in (2) of this clause;
- (4), (5) two persons appointed by Council;
- (6) a person appointed by the Social Sciences Board;
- (7)-(9) three persons appointed by the Oxford School of Global and Area Studies.
- 4. Any part of the income of the endowment of the <u>Pp</u>rofessorship which is not required to meet the costs (including support costs) thereof may be expended, under conditions to be determined from time to time by the Oxford School of Global and Area Studies Committee (the OSGA Committee), to support teaching and research in <u>African Studiesinterraeial relations</u>. The OSGA Committee shall appoint a <u>Professorship of African StudiesRhodes Professor of Race Relations</u> Management Committee to advise it. That committee will consist of:
- (1) the Head of the Oxford School of Global and Area Studies;
- (2) an appointee of the Social Sciences Division;
- (3) the <u>Professor of African Studies Rhodes Professor of Race Relations</u>;
- (4) the head of the college in which the post-holder is based.
- 5. The <u>P</u>professor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations which are applicable to this chair.

- 6. Subject to regulation 7, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
- (1) cease to be exclusively charitable according to the law of England and Wales; or
- (2) be outside the objects of the University.
- 7. Any amendment to regulation 2 is an amendment to the main object of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by His Majesty in Council.'

- 4) St Peter's Churchyard, Glenfield, Leicestershire (as shown hatched on the plan annexed hereto).


In pursuance of the Orders in Council made on 11th October 2023 these representations have been published and taken into consideration by a Committee of the Privy Council.

Accordingly, His Majesty, in exercise of the powers conferred on Him by section 1 of the Burial Act 1853, is pleased, by and with the advice of His Privy Council, to order that burials shall be discontinued forthwith in the places listed above, subject to the following exceptions:-

- (a) in the place numbered 1 and 2 above, in any vault or walled grave in the churchyard, burial may be allowed but every coffin in such vault or grave must be separately enclosed by stonework or brick work properly cemented;
- (b) in places numbered 1, 2, 3 and 4 above, in any existing earthen grave in the churchyard, the burial may be allowed of the body of any member of the family of the person or persons previously buried in that grave, but no part of the coffin containing the body shall be less than one metre below the level of the surface of the ground adjoining the grave; and

(c) in the paces numbered 1, 2 and 3 above, in any grave space in which no interment has previously taken place, the burial may be allowed of any person for whom, or any member of the family for which that grave space has been reserved and appropriated, with the exclusive right of burial there, but no part of the coffin containing the body shall be less than one metre below the level of the surface of the ground adjoining the grave.




