BUSINESS FOR THE COUNCIL

1. PRIVY COUNSELLORS

Sir Peter Fraser was sworn as a Member of His Majesty's Most Honourable Privy Council.

The Rt Hon Lord Beckett, the Rt Hon Stephen Flynn MP and the Rt Hon Gavin Robinson MP made affirmation as Members of His Majesty's Most Honourable Privy Council.

2. PROCLAMATIONS

A Proclamation appointing Thursday, 26th December 2024 and Monday, 26th May 2025, as Bank Holidays in Scotland.

Five Proclamations determining the specifications and designs for a new series of coins:-

1. depicting the Queen's Panther;
2. depicting mythical legend Little John;
3. depicting a Lion and an Eagle;
4. depicting characters from the Gruffalo's Child and Harry Potter;
