A Proclamation appointing Thursday 1st January 2026, Monday 4th May 2026 and appointing Monday 28th December 2026 in place of Saturday 26th December 2026 as Bank Holidays in England, Wales and Northern Ireland and appointing Monday 13th July 2026 as a Bank Holiday in Northern Ireland.

- 3. St Mary's Church Churchyard, Chigwell, Essex;
- 4. St Mary's Churchyard, Ditchingham, Norfolk;
- 5. St Nicholas Churchyard, Frankton, Rugby, Warwickshire.

## **Burial Act 1855 (Variation)**

Order varying an Order dated 11th December 1854 prohibiting further burials in the Churchyard of St Mary's, Ottery St Mary, Devon.
